Georgeann Jouflas, Event Manager was present. Mr. Coebergh asked if they had checked any other facilities. Ms. Jouflas stated they had, the Adams Mark and Two Rivers and neither facility was available as they believe there will be approximately 1500 people in attendance.

Mr. Shaver indicated the last several special events applications that have come before the licensing authority have had other components that in the state statute (12-48-103) does not address. Staff is researching this statute more broadly regarding the inadequacy of other facilities versus the needs of the organization requesting the special events permit and that "additional facilities are necessary by reason of the nature of the special event being scheduled". Mr. Shaver was satisfied that the statutory requirements have been met. The application was found to be in order and approved.

VI. APPLICATION FOR MODIFICATION OF PREMISES
