#### **MINUTES**

#### WEDNESDAY, November 5, 2003, 9:00 A.M.

Lynne Sorlye, Manager, was present.

Ms. Kemp stated that Mesa County Health Department had reported the applicant had not yet made application for a retail food license.

Ms. Sorlye stated that they had obtained a retail food license.

Mr. Shaver asked Ms. Kemp if the corporate paperwork for Western States Restaurant Operation LLC is in order. Ms. Kemp stated that it was.

The application was found to be in order and approved contingent on a report from Mesa County Health Department stating that application for a retail food license has been obtained.

#### VI. RESOLUTION OF FINDINGS AND DECISION RE: APPLICATION FOR NEW LICENSE

1. Tyluk, Inc., dba Cowboyz, 490 28 ¼ Road, Tavern

President: President, Louis H. Boyd, Jr., 1277 N Rd., Loma, CO 81524

Mr. Louis Boyd, President of Tyluk, Inc. was present. Ms. Kemp read into the record the results of the survey (see attached). Mr. Majors asked about the disqualified numbers in

the survey. Ms. Kemp stated that the disqualifications were addresses surveyed out of the given boundaries. Mr. Shaver questioned when and how the survey for needs and desires was conducted and who conducted the survey. Mr. Boyd explained that three future employees conducted the survey between Oct. 27<sup>th</sup> and 28<sup>th</sup> during the daytime. Mr. Shaver asked why a larger number of residents weren't surveyed as the given boundaries had a lot of residential area. Mr. Boyd replied that he is not sure why a larger number of residential were not surveyed. Mr. Shaver asked Mr. Boyd if he reviewed the results of the survey and found them to be true and accurate. Mr. Boyd said he did.

There was no opposition present.

Mr. Majors asked Mr. Boyd when he anticipated a final building inspection would be performed. Mr. Boyd explained that they had run into problems with the design, but was anticipating a final inspection in two to three weeks.

The application was approved contingent upon a good report from the Mesa County Health Department, the Fire Department and issuance of a Certificate of Occupancy from the Building Department. A resolution of findings and approval will be prepared for Mr. Major's signature.

Tyluk, Inc. filed an application with the Local Licensing Authority on October 3, 2003, for a new tavern liquor license for the sales of malt, vinous and spirituous liquors by the drink for consumption on the premises at 490 28 ¼ Road under the trade name of Cowboyz. The application and supplementary documents were reviewed, found to be in order and accepted. The hearing date was set for November 5, 2003. The Notice of Hearing will be given by posting a sign on the property on October 25, 2003 and by publishing a display ad in The Daily Sentinel on October 24, 2003.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. The neighborhood was defined as the area bounded by Texas Avenue on the North; I-70 Business Loop on the South; Melody Lane on the East; and 23<sup>rd</sup> Street, if extended, on the West as the outer boundaries. The results of that survey are as follows:

1. As an owner of property in the neighborhood, an employee or a business lessee of property in the neighborhood, and/or an inhabitant residing in the neighborhood for more than six months each year, I believe the reasonable requirements of the neighborhood are already being met by other existing outlets.

YES: 0 NO: 60

Disqualified: 37

2. As an inhabitant who resides in the neighborhood more than six months each year, it is my desire that the license be issued.

YES: 34 NO: 0

N/A: 26

Disqualified: 37

No letters of opposition or counterpetitions have been filed to date.

The Grand Junction Police Department is investigating the President of the Corporation for local criminal history. The fingerprints have been forwarded onto CBI for further processing. The premises will be inspected by the Grand Junction Fire Department, Mesa County Health Department and the Mesa County Building Department for compliance prior to the issuance of a license.

The number of similar-type outlets in the survey are as follows:

Tavern – 2 (Brass Rail Lounge and Fast Eddy's)

The number of similar type outlets in a one mile area in addition to the above:

Tavern – 1 (Freeway Bowl)
