Mr. Shaver asked about the number of signatures and if Mr. Barbier conducted the survey in the residential area. Mr. Barbier stated the other two did that area and he concentrated on Main and White Streets. Mr. Majors asked what time of day and what day of the week. Mr. Barbier stated both am and pm but did not know the day of the week the survey was conducted.

Mr. Majors asked if anyone was in opposition or if any counter petitions were received. Ms. Peterson stated no counter petitions were received. Mr. Majors stated the applicant has met the evidence criteria and he authorized the issuance of this license. The City Clerk's Office will prepare a resolution for his signature.

License at 317 Main Street, under the trade name of Rendez vous of GJT, Ltd.

Rendez vous of GJT, Ltd. filed an application with the Local Licensing Authority on December 31, 2003, for a new hotel and restaurant liquor license for the sales of malt, vinous and spirituous liquors by the drink for consumption on the premises at place where sold at 317 Main Street, under the trade name of Rendez vous of GJT, Ltd. The application and supplementary documents were reviewed, found to be in order and accepted. The hearing date was set for February 4, 2004. The Notice of Hearing was given by posting a sign on the property on or before January 23, 2004 and by publishing a display ad in The Daily Sentinel on January 23, 2004.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey and defined the neighborhood as the area bounded by Teller Avenue to the North, 4th Avenue to the South, 9th Street to the East and West Avenue to the West and includes both sides of the street as the outer boundaries. The results of that survey are as follows:

1. As an owner of property in the neighborhood, an employee or a business lessee of property in the neighborhood, and/or an inhabitant residing in the neighborhood for more than six months each year, I believe the reasonable requirements of the neighborhood are already being met by other existing outlets.

The Grand Junction Police Department has investigated the individual for local criminal history and none was found. The fingerprints have been forwarded onto CBI for further processing. The premises have been inspected by the Grand Junction Fire Department and the Mesa County Health Department and are in compliance.
