**MINUTES**

**WEDNESDAY, March 3, 2004, 9:00 A.M.**

I. **CALL TO ORDER** - The meeting convened at 9:04 a.m. Those present were Hearing Officer Phil Coebergh, Acting City Attorney John Shaver and Deputy City Clerk Juanita Peterson

II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**

1. Dancing Spirits LLC, dba Horizon Liquor, 715 Horizon Dr., Retail Liquor Store

The application was found to be in order and approved.

2. City of Grand Junction, dba Two Rivers Convention Center, 159 Main Street, Hotel and Restaurant

The application was found to be in order and approved.

III. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES AND REGISTRATION OF NEW MANAGER WITH LATE FILING**

1. Carino's Italian Kitchen Inc., dba Johnny Carino's Country Italian, 2480 Highway 6 & 50, Hotel and Restaurant

Jason Rhines replaces Jared Ettleson as manager

Mr. Rhines was present. Mr. Coebergh acknowledged the letter from Mr. Proff regarding the late filing of the manager on behalf of Johnny Carino's. Mr. Shaver asked Mr. Rhines if he would remain the general manager in the foreseeable future. Mr. Rhines stated the General Manager usually is at one location for 12-18 months. The application was approved for renewal and the registration of a new manager.

IV. **REVIEW OF A LIQUOR LICENSE**

1. Ray W. Quan (Estate of), dba Far East Restaurant, 1530 North Avenue, Hotel and Restaurant, Review Status of Estate

Mr. Thomas Quan was present and stated that the estate is still in probate. He is hoping by August this will be cleared up but there are five family members to agree on everything. Mr. Shaver asked if there was two licenses involved, one from the State in the name of Ray Quan and one in the name of the Estate of Ray Quan. Ms. Peterson stated that from the Clerk's Office there was only one license in the name of Ray Quan, not the estate. Mr. Coebergh and Mr. Shaver agreed that until the renewal they won't need an additional update from Thomas Quan, but that once this is settled, it will need to be taken care of with a Transfer of Ownership.

V. **APPLICATION FOR SPECIAL EVENTS PERMITS**

1. Application by Latin Anglo Alliance Foundation for a Malt and Vinous Special Events Permit for Cinco de Mayo Celebration on May 8, 2004 from 6:00 a.m. to 11:00 p.m. located on Main Street between 5<sup>th</sup> & 7<sup>th</sup> Streets, 6<sup>th</sup> Street between Colorado and Rood
