**MINUTES**

**WEDNESDAY, June 2, 2004, 9:00 A.M.**

I. **CALL TO ORDER** – The meeting convened at 9:02 a.m. Those present were Hearing Officer Phil Coebergh, City Attorney John Shaver and Deputy City Clerk Debbie Kemp.

II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**

1. Spirit of Grand Junction, LLC. dba Redlands Liquor, 2500 A Broadway, Retail Liquor Store

The application was found to be in order and approved.

2. Loco, Inc. dba Loco Food Store No. 15, 722 Horizon Dr., 3.2% Beer Retail (Off Premises)

The application was found to be in order and approved.

3. Tequila's II, Inc. dba Tequila's, 2560 North Avenue, Hotel and Restaurant

The application was found to be in order and approved.

III. **APPLICATION TO RENEW LIQUOR LICENSE WITH LATE FILING**

1. Genco Olive Oil, Inc. dba The Winery Restaurant, 642 Main Street, Hotel and Restaurant

Chris Blackburn, President of Genco Olive Oil, Inc. was present.

Ms. Kemp reported that the application was in order, however, Mesa County Health Department had sent the establishment a compliance warning letter as part of a civil penalty process due to a cold holding violation.

Mr. Blackburn stated that they have gotten the refrigeration recharged and it is now holding the temperature as required.

Mr. Blackburn addressed the late filing by stating that it was his own error. His secretary had given him the renewal, but he had laid it on his desk and it was buried and missed the deadline to turn it in on time.

Mr. Shaver asked Ms. Kemp if the application for renewal was turned in prior to the expiration of the liquor license. Ms. Kemp advised that it was.

The application was found to be in order and approved.

**IV. REPORT OF CHANGE IN CORPORATE STRUCTURE – Master File is Maintained in Denver**

1. CEC Entertainment, Inc. dba Chuck E. Cheese's, 2424 US Hwy 6 & 50 #232, Hotel & Restaurant

Vice President/Treasurer: James Alan Mabry replaces Rodney Carter

Ms. Kemp reported that they have a master file with the state and have already filed with the state. Approval on the local level is just a formality.

The application was found to be in order and approved.

Mr. Griff advised that, along with the Ribber providing food, Old Buttercup would be providing ice cream and that wasn't stated in the application when submitted. Mr. Griff asked if it would be alright for Two Rivers Winery to sell bottles of wine at the event as well as by the glass. Mr. Shaver advised Mr. Griff that the Special Events Permit only allows for the sale of wine by the glass and Two Rivers would have to obtain a special limited wine tasting permit though the state to be able to sell wine by the bottle.

The application was found to be in order and approved.
