WEDNESDAY, JULY 6, 2005, 9:00 A.M.

I. <u>CALL TO ORDER</u> – The meeting convened at 9:01 a.m. Those present were Hearing Officer Jim Majors, City Attorney John Shaver and Deputy City Clerk Debbie Kemp.

II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

1. Diorio's Pizza, Inc. dba Diorio's on Horizon, 759 Horizon Drive, Beer and Wine (continued from June 15, 2005)

Ms. Kemp reported that Mesa County Health Department advised that the critical violation had been corrected.
