Mr. Majors found the requirements have been met and approved the issuance of the hotel and restaurant liquor license on a local level pending the final certificate of occupancy being given. The City Clerk's office will prepare a resolution for Mr. Major's signature.

Mr. Majors asked if the City Clerk's office has received any opposition to the application. Ms. Peterson stated no.

The City Clerk's office will prepare a resolution for Mr. Major's signature. Ms. Peterson said this was sent to the State for a concurrent review and should be back by mid next week.

VIN Hospitality LLC filed an application with the Local Licensing Authority on June 8, 2006 for a new hotel and restaurant liquor license permitting sales of malt, vinous and spirituous liquors by the drink for consumption on the premises at 626 Rood Avenue under the trade name of 626 On Rood – Modern American Cuisine and Wine Bar. The application and supplementary documents were reviewed, found to be in order and accepted. The hearing date was set for July 19, 2006. The Notice of Hearing was given by posting a sign on the property on or before July 9, 2006 and by publishing a display ad in the Daily Sentinel on July 7, 2006.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. Junction Bingo LLC filed an application with the Local Licensing Authority on June 14, 2006 for a new beer and wine liquor license permitting sales of malt and vinous liquors by the drink for consumption on the premises at 511 28 ¼ Road under the trade name of Junction Bingo LLC. The application and supplementary documents were reviewed, found to be in order and accepted. A copy was sent to the State Liquor Enforcement Division for a Concurrent Review.
