MINUTES

WEDNESDAY, SEPTEMBER 20, 2006 9:00 a.m.

I. <u>CALL TO ORDER</u> – The meeting convened at 9:03 a.m. Those present were Hearing Officer Phil Coebergh, City Attorney John Shaver, and Deputy City Clerk Debbie Kemp.

II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

David Prather, owner of Wigout Productions, Inc., was present. Ms. Kemp reported that the application for renewal was continued due to the report from the Police Department showing several incidents reported at the establishment and a report had not been received from the Health Department. She reported that the Health Department found one critical violation which was corrected at the time of inspection.

City Attorney John Shaver stated that the applicant was also requested to be present because they were required to be present at all renewal hearings. He had reviewed the police log and found that it isn't clear whether or not the incidents reported were a direct negligence of the establishment. He will continue to monitor the police activity.
