MINUTES

WEDNESDAY, MARCH 7, 2007 9:00 a.m.

CALL TO ORDER - The meeting convened at 9:00 a.m. Those present were Hearing Officer Mike Grattan, City Attorney John Shaver, and Deputy City Clerk Juanita Peterson.

II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

 GA Restaurant Inc., dba Wrigley Field, 1810 North Avenue, Grand Junction CO 81501, Hotel and Restaurant

Mr. Gary Duke was present as the manager of the establishment along with Captain Eric Cox of the Grand Junction Fire Department. Mr. Duke explained that someone broke the back door and stole neon signs out of the establishment and the door was not fixed. From 1987 until 2004 this was never used as a door.

City Attorney Shaver asked Mr. Duke if the door was fixed. Mr. Duke said yes that Simmons Lock and Key fixed the door.

Captain Cox wanted to reference that the rear door is now required since the remodel and that area of the establishment is now being used. Prior there was only limited usage in that area. Captain Cox stated the Fire Department has no outstanding issue currently with the establishment and Mr. Duke had the door fixed in a timely manner, but wanted the Authority on notice of what has taken place. Captain Cox said they will be making non-scheduled visits to the establishment to make sure the door remains unlocked and in proper operating condition.

Hearing Officer Grattan and City Attorney Shaver concurred the licensed be renewed.

City Attorney Shaver said in reference to 12-48-103, C.R.S. regarding that existing licensed facilities are inadequate for the purposes of serving members or guests of the organization or political candidate and that additional facilities are necessary by reason of the nature of the special event, that the statute has been complied with and recommends approval.

Hearing Officer Grattan concurred with City Attorney Shaver and approved the special events permit.

Hearing Officer Grattan stated at this time Mr. Reyes has compiled with the request from the Authority.
