MINUTES

WEDNESDAY, MARCH 21, 2007 9:00 a.m.

I. **CALL TO ORDER** - The meeting convened at 9:05 a.m. Those present were Hearing Officer Mike Grattan and Deputy City Clerk Juanita Peterson. City Attorney John Shaver was absent.

II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**

1. Carino's Italian Kitchen Inc. dba Johnny Carino's Italian Restaurant, 2480 Hwy 6 & 50, Grand Junction, CO 81505, Hotel and Restaurant

Ms. Peterson reported the paperwork was in order; all reports were fine except for Mesa County Health Department which will re-inspect the premises on March 27, 2007 to make sure all critical violations are corrected. Hearing Officer Grattan approved the renewal contingent on a satisfactory report from the Health Department.

2. Grand Conjunction LLC dba Doubletree-Grand Junction, 743 Horizon Drive, Grand Junction, CO 81506, Hotel and Restaurant

Mr. Lee Roberts, Food and Beverage Director was present. The application was in order and approved.

3. Horizon Drive Shell LLC dba Horizon Drive Shell, 745 Horizon Drive, Grand Junction, CO 81506, 3.2 % Beer Retail (Off-Premises)

Ms. Florence Vaimajalo representing Horizon Drive Shell was present. Ms. Peterson reported that the application was in order; the police report explained the establishment was involved in the "sting" operation in June, 2006 and received a violation for selling to a minor. The sales tax report was fine. Ms. Peterson read the letter submitted by the owner, Mr. Gary Dean, into the record.

Hearing Officer Grattan asked Ms. Vaimajalo what kind of training their employees receive. Ms. Vaimajalo reported when an employee is hired within their employee packet it explains the requirements and also the cash registers prompt the employee with the correct year to make sure the customers are 21 years of age to check their ID's.

Ms. Peterson stated none of the employees from Horizon Drive Shell have attended the Seller Server responsibility training the City offers free of charge. The next training is April 7th. Ms. Vaimajalo stated that she just received the flyer and they hope to send some employees.

Hearing Officer Grattan encouraged Ms. Vaimajalo to have employees attend but did not make it a requirement. He approved the renewal.

4. Red Robin International Inc., dba Red Robin Gourmet Burgers, 2530 Rimrock Avenue, Grand Junction, CO 81505, Hotel and Restaurant

Ms. Peterson asked that this be continued until April 4, 2007 as it was her mistake, the reports were completed but not submitted to the different agencies for their reporting of the establishment.

Mr. Jon Stonbraker with Dill, Dill, Carr, Stonbraker and Hutchings, PC was present on another matter but also represents Red Robin on licensing issues and he had no problem with continuing the renewal and asked to be notified if there were any issues regarding the renewal. Ms. Peterson said she would personally contact him to confirm this before the next hearing.

5. Rite Aid Corporation dba Rite Aid #6258, 2992 F Road, Grand Junction CO 81504, 3.2 % Beer Retail (Off-Premises)

The application was in order and approved.

V. STIPULATION IN THE MATTER OF REYES TAQUERIA

1. Benito Reyes, dba Reyes Taqueria, 511 30 Road, Grand Junction, CO 81504, License No. 42-34138-0000, Hotel and Restaurant

Staff Attorney Shelly Dackonish was present and reported to the Authority that she is still waiting for a couple of days' receipts to complete her investigation.

Hearing Officer Grattan wanted a date certain that this would be completed and it was rescheduled for April 18, 2007 and Ms. Dackonish agreed to this. It was also agreed by both that Mr. Reyes has met the requirement the Authority has asked of him and would not need to be present at the April 18, 2007 hearing.

III. APPLICATION FOR SPECIAL EVENTS PERMIT

1. City of Grand Junction Parks & Recreation Department dba Southwest Fest, 1340 Gunnison Avenue, Grand Junction, CO 81501, April 21, 2007

Mr. Larry Manchester, Event Manager for this event and a supervisor with the City of Grand Junction Recreation Department was present. Ms. Peterson stated the paperwork was submitted in a timely manner and all of the reports came back fine. She read into the record the letter submitted by the applicant regarding other licensed facilities.

Hearing Officer Grattan said in reference to 12-48-103, C.R.S. regarding that existing licensed facilities are inadequate for the purposes of serving members or guests of the organization or political candidate and that additional facilities are necessary by reason of the nature of the special event, that the statute has been complied with. He approved the special event permit.

IV. APPLICATION FOR NEW LICENSE - RESOLUTION OF FINDINGS AND DECISION

1. Chipotle Mexican Grill Inc., dba Chipotle Mexican Grill, 2504 Hwy 6 & 50, Ste. 300, Grand Junction CO 81505, Hotel and Restaurant

Mr. Jon Stonbraker, Attorney with Dill, Dill, Carr, Stonbraker and Hutchings, PC was present representing the applicant along with Ms. Susan Duffy Schwall, Liquor Licensing Professionals, who conducted the survey of the needs and desires of the neighborhood, and Mr. David Cannon, District Manager for Chipotle Mexican Grill, Inc.

Hearing Officer Grattan swore-in Ms. Schwall for her testimony regarding the survey, and asked her to explain how the survey was conducted, and the experience of her company. Ms. Schwall explained her background is in law enforcement and she has about 10 years experience with this company which she bought later. Ms. Schwall described the process her company goes through once they are hired by an applicant. On this survey there were 4 circulators and they worked from the proposed restaurant out into the survey area towards the outer boundary. The survey was conducted Friday afternoon and then late morning on Saturday. Ms. Schwall stated the standard exchange between her employees and residents/businesses that are contacted and they are identified by name tags and they explain the purpose of the survey. Hearing Officer Grattan asked Ms. Schwall regarding the results of her survey versus the results presented by Ms. Peterson. Hearing Officer Grattan asked Ms. Schwall if the document marked Exhibit A was her computation of the survey results and if the map he labeled as Exhibit A1 was the survey area. Ms. Schwall answered yes. The total was off by one and Ms. Schwall said she would agree to accept Ms. Peterson's results. Ms. Peterson's results are marked Exhibit B (see attached).

Hearing Officer Grattan asked Ms. Schwall additional questions on how generally the public responds to the survey. Officer Grattan asked if there is ever 100% in favor of the new application. Ms. Schwall said she has conducted a minimum of over 150 surveys in 4 years and there has never been 100% in favor of issuance of a liquor license due to numerous reasons.

Hearing Officer Grattan had questions for Mr. Cannon who was also sworn-in. Attorney Stonbraker asked Mr. Cannon to describe Chipotle Inc. Mr. Cannon stated they have 60 licenses in the State and 600 nationwide and they are a publicly traded company. They are a casual quick service Mexican restaurant. Mr. Cannon stated they ID everyone ordering alcoholic beverages no matter how old they appear. Mr. Cannon described the outdoor dining area with the metal railing to secure the area along with clear glass windows so the store manager has good visual site of the area at all times. Hearing Officer Grattan asked about the training the employees receive. Mr. Cannon stated there are 4 days of training for the employees and Chipotle's will be in contact with the City Clerk's office regarding the training offered here locally. Mr. Cannon also stated the beverage to food sales is less than 1%. Mr. Stonbraker or Hearing Officer Grattan had no other questions for Mr. Cannon.

Hearing Officer Grattan asked if there was anyone present for or against the application. Seeing none, Mr. Grattan found the requirements have been met and approved the issuance of the hotel and restaurant liquor license on a local level. The City Clerk's Office will prepare a resolution for Mr. Grattan's signature. Ms. Peterson stated this was a concurrent review with the State and the license will be issued upon receiving the final CO.

2. Thai Chili Inc., dba Thai Chili Restaurant, 2536 Rimrock Drive, Suite 700, Grand Junction CO 81505, Beer and Wine

President: Mei Zhang Ya, 675 Roundup Dr, Grand Junction CO 81503

Manager: Mei Zhang Ya.

Ms. Cindy Hale of Hale Bookkeeping was present as Ms. Zhang's accountant and will be the representative of Ms. Zhang to the best of her knowledge and to help interpret for Ms. Zhang. Ms. Hale stated she was not a part of the survey but she helped complete the paperwork for the application and has worked with the City Clerk's office on coordinating with the applicant.

Ms. Peterson reported the application was in order, all of the reports came back fine. Ms. Peterson read the results of the survey into the record (see attached).

Hearing Officer Grattan swore-in Ms. Zhang. Mr. Grattan explained that he will ask questions in the same manner he did for the previous applicant regarding the survey. He labeled the survey petitions Exhibit A and B, and the map of the survey area C, and asked Ms. Zhang if these were the petitions she circulated (see attached). Ms. Zhang stated yes. Hearing Officer Grattan asked Ms. Zhang how she conducted the survey. Ms. Zhang said door to door and she remained within the boundaries. Hearing Officer Grattan asked about the 68 signatures that were disqualified. Ms. Peterson stated these were out of the survey area. Hearing Officer Grattan asked Ms. Zhang about this. Ms. Zhang said at first she thought anyone could sign. Hearing Officer Grattan asked if the survey form was left in the restaurant. Ms. Zhang said yes. Ms. Zhang said there were several who refused to sign the petition.

Hearing Officer Grattan asked Ms. Zhang if she remembered the testimony from Ms. Schwall in the case previous to hers where she testified that she has never had 100% in favor of the issuance of a liquor license in all the surveys she has done. The results that Ms. Zhang presented in her survey was that no one objected. Hearing Officer Grattan stated that he does not believe the results presented represented the needs and desires of the neighborhood accurately. Hearing Officer Grattan told Ms. Zhang that he could deny the license, but he would really like to extend this for two more weeks and give Ms. Zhang a chance to get additional signatures on new petitions. He believes the methodology was faulty and explained it is okay to have persons sign that are against this license. Ms. Peterson explained it would be a good idea to keep track of the number of people who might not want to sign the petition, and the "not at homes" and be able to report this back to the Hearing Officer on April 4th.

Hearing Officer Grattan set this over until April 4, 2007 and asked Ms. Peterson when the survey would be due to give the City Clerk's office time to verify the signatures. Ms. Peterson said if the survey would be due back to them by March 28th then they would have time to verify the signatures and would compile both surveys and present a final result for the Authority. Hearing Officer Grattan asked Ms. Zhang if she understood this and she said yes.

- Survey Dates and Times:** Business: Friday March 2, 2007 3:00pm – 5:30pm
 Residential: Saturday March 3, 2007 11:30am - 3:40pm
- Survey Areas:** Businesses were contacted in areas closest to the site of Chipotle Mexican Grill, to the West, North and East. Residents were contacted in the area between 1st St and 25.5 Rd and between Patterson Rd. and North Ave. Please see attached map.
- Circulators of the Survey:** There were four circulators of this survey. Prior to the start of the survey, the circulators were briefed on the type of liquor license application, the areas to be surveyed and reminded to be completely unbiased in their approach to residents and business people. The circulators had with them a face sheet with the applicant business name, location and hearing information, instructions and the petition/survey issue along with signature sheets and a map of the proposed location. The circulators used tally sheets to record all contacts, attempts and reasons for opposition signatures and refusals. At the conclusion of the survey, the circulators signed notarized affidavits of circulation.



SUBJECT: Application for a new hotel and restaurant liquor license by Chipotle Mexican Grill Inc. dba Chipotle Mexican Grill, 2504 Highway 6 & 50, Suite 300.

Chipotle Mexican Grill Inc. filed an application with the Local Licensing Authority on February 16, 2007 for a new hotel and restaurant liquor license permitting sales of malt, vinous and spirituous liquors by the drink for consumption on the premises at 2504 Highway 6 & 50 under the trade name of Chipotle Mexican Grill. The application and supplementary documents were reviewed, found to be in order and accepted. A copy was sent to the State Liquor Enforcement Division for a Concurrent Review. The hearing date was set for March 21, 2007. The Notice of Hearing was given by posting a sign on the property on or before March 11, 2007 and by publishing a display ad in the Daily Sentinel on March 9, 2007.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. The neighborhood was defined as the area bounded on the North by Patterson Avenue, on the South by Colorado River, on the East by 1st Street, and on the West by 24 Road. The results of that survey are as follows:

The Grand Junction Police Department has investigated the owners for local criminal history. There is a master file on record with the State which reflects current CBI/FBI reports. Reports have been requested by the Grand Junction Fire Department, Code Enforcement, Mesa County Health Department, and City of Grand Junction Sales Tax Department and the Building Department for a final certificate of occupancy (CO) upon completion of the restaurant.

The number of similar-type outlets in the survey area is as follows:

Hotel and Restaurant – 14 (Chili's, Tequilas, Genghis Grill, Bear Rock Café, Johnny Carino's Red Robin, Qdoba Mexican Grill, Fly'n Roosters, Outback Steak House, Olive Garden, Chuck E. Cheese, Boston The Gourmet Pizza, Red Lobster)




