**MINUTES**

**WEDNESDAY, MAY 2, 2007 9:00 a.m.**

I. **CALL TO ORDER** – The meeting convened at 9:01 a.m. Those present were Hearing Officer Mike Grattan, City Attorney John Shaver and Deputy City Clerk Debbie Kemp.

II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**

1. **Bank 8 Billiards, Inc.** dba Bank 8 Billiards, 2460 F Road, #3, Grand Junction, CO 81505, Tavern

The application for renewal was found to be in order and approved.

2. **D L K Enterprises, Inc.** dba Brass Rail Lounge, 476 28 Road, Grand Junction, CO 81501, Tavern

The application for renewal was found to be in order and approved.
