

ORDINANCE NO. 456

THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF GRAND JUNCTION, COLORADO, PROVIDING FOR THE EXPENSES AND LIABILITIES OF THE CITY OF GRAND JUNCTION FOR THE FISCAL YEAR BEGINNING JANUARY 1st, A. D. 1930, AND ENDING DECEMBER 31st, A. D. 1930, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO.

Section 1. That the following sums of money or so much thereof as may be necessary, be and the same are hereby appropriated for the purposes of defraying the necessary expenses and liabilities of the City of Grand Junction, Colorado, for the fiscal year beginning January 1st, 1930, and ending December 31st, 1930, to-wit:

FIRST:	For Interest and Principal on General City Bonds.....	\$24,092.50
SECOND:	For Community Service.....	2,940.75
THIRD:	For Maintaining the Fire Department..	15,421.00
FOURTH:	For the Contingent Fund.....	11,548.00
FIFTH:	For the Engineering Department.....	6,680.00
SIXTH:	For Maintaining and Improving Health Conditions of the City.....	10,431.50
SEVENTH:	For Maintaining and Improving Streets & Alleys.....	19,606.00
EIGHTH:	For Maintenance and Operation of Moyer Pool.....	2,700.00
NINTH:	For Maintenance Free Public Library..	4,500.00
TENTH:	For Lighting Streets and Alleys & Parks.....	15,744.00
ELEVENTH:	For Salaries of Officers, Office Supplies, Printing, Fuel, Lights, & Telephone.....	16,579.20
TWELFTH:	For Maintaining and Improving the Public Parks and Cemeteries.....	20,783.00

Section 2. That for the purpose of defraying the necessary expenses and liabilities of the said City of Grand Junction, Colorado, for the fiscal year beginning January 1st, 1930, and ending December 31st, 1930, there shall be and hereby is levied and assessed upon all the taxable property situated within the corporate limits of the City of Grand Junction, both real and personal, for the purposes of defraying the necessary expenses and liabilities and water works purposes of the said City of Grand Junction, and for the payment of interest on outstanding bonds and for the payment of a portion of the bonded indebtedness of said City, a tax of thirteen and one half mills on each dollar of said property so assessed.

Section 3. By reason of the fact that this ordinance must be in effect on January 1st, 1930, a special emergency is declared to exist and the City Council finds and determines that the passage of this ordinance is immediately necessary for the preservation of the public, peace, health, and safety, and that it shall take effect upon its passage.
