## MINUTES

# WEDNESDAY, JUNE 4, 2008 9:00 a.m.

I. <u>CALL TO ORDER</u> – The meeting convened at 9:00 a.m. Those present were Hearing Officer Mike Grattan, City Attorney John Shaver, and Deputy City Clerk Juanita Peterson.

### II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

1. **Loco Inc.,** dba Loco Food Store No. 15, 722 Horizon Drive, Grand Junction, CO 81505, 3.2% Retail Beer Off Premises

Julie Holler, Store Manager, was present. Ms. Peterson reported the paperwork was in order, was filed in a timely manner and the applicant revealed that their license was suspended for two days, February 14 and 15, 2008 due to the stipulation received from the State Liquor Enforcement Division on November 2, 2007. They had an employee who sold to an underage person. Ms. Holler explained the program that store uses to train their employees and how each item of alcohol has a tag on it which needs to be entered into the system with proof of identification and age before being sold. She worked with Liquor Enforcement Officer Brian Turner on getting this at all their stores.

Hearing Officer Grattan and City Attorney Shaver commended Ms. Holler on the efforts of Loco Inc. for getting this at all their stores. The application for renewal was found to be in order and approved.

2. **Feather Petroleum Company,** dba Stop N Save No. 4, 2700 Highway 50, Grand Junction, CO 81503, 3.2% Retail Beer Off Premises

There was no one present representing the applicant.

The applicant revealed that Store No. 3 was involved in a sting operation, and on January 24<sup>th</sup> and 25<sup>th</sup>, 2008 their license was suspended at Store No. 3 which has the same ownership as the renewal today. Ms. Peterson stated they suggest someone be present but has never insisted. Hearing Officer Grattan said he would appreciate that being done.

Ms. Peterson reported this is a concurrent review. All the paperwork was in order. The General Manager has been replaced with one of the owners until a new General Manager (GM) is named. All the reports are fine, the C.B.I. report is still pending. Ms. Fathom Jensen was present. Ms. Jensen is the General Manager for the Marriott Courtyard and working operations at the Residence Inn until the new GM is hired. Ms. Jensen said the new GM has been selected and the paperwork will be forthcoming. City Attorney Shaver clarified with Ms. Jensen that RLJII-R Grand Junction is now the Lessee along with some of the previous ownership. She stated this is correct; Mr. Bruce H. Etkin is no longer on the ownership and has sold some of his holdings.

Hearing Officer Grattan asked who is the manager. Ms. Peterson reported that Mr. Bruce White was named currently as the manager. Hearing Officer Grattan asked if Mr. White lived in Grand Junction. Ms. Jensen reported that he does not live here, but in Chicago. Ms. Peterson stated she has spoken with the attorneys who are handling this for the owners and this will be coming before the Authority within the next several weeks.

Hearing Officer Grattan approved the transfer of ownership subject to a review in 60 days if the paperwork to register a new manager has not been submitted to the City Clerk's office.
