## MINUTES

# WEDNESDAY, AUGUST 20, 2008 9:00 a.m.

I. <u>CALL TO ORDER</u> – The meeting convened at 9:00 a.m. Those present were Hearing Officer Mike Grattan, City Attorney John Shaver, and Deputy City Clerk Juanita Peterson.

#### II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

1. Knaysi Enterprises Inc., dba Pablo's Pizza, 319 Main Street, Grand Junction, CO 81501, Beer and Wine

There was no one present representing the applicant. Ms. Peterson reported that the paperwork was filed in a timely manner and all reports came back fine.

The renewal was approved.

Jim Jeffryes, President, was present. Ms. Peterson reported that the paperwork was filed in a timely manner and all reports came back fine except the report from Mesa County Health Department. Ms. McKissen submitted a report of her concern with an opening between the building and the outside walk-in cooler that has created an area that is always open (not a sealed insect and rodent proof area). To correct this violation she recommended that the Building Inspection Department meet with the owners.

Mr. Jeffryes said he has met with Building Inspector Mike Moshberg, who recommended a flashing be installed along the opening.

Hearing Officer asked Mr. Jeffryes if the Health Department has re-inspected the premises. Mr. Jeffryes said he would call the Health Department and have it re-inspected by Ms. McKissen.

Hearing Officer Grattan and City Attorney Shaver concurred to approve the renewal subject to the Health Department being satisfied.

Josh Zambrano, Manager, was present. Ms. Peterson reported that the paperwork was filed in a timely manner. Mr. Zambrano did reveal on his Individual History Statement the two incidents, one in 1994 and one in 1996 which did come back on his C.B.I./F.B.I. report. Ms. Peterson also read the results of the survey into the record (see attached).

City Attorney Shaver asked Mr. Zambrano if he agreed with the results read into the record. Mr. Zambrano agreed. City Attorney Shaver asked who conducted the survey. Mr. Zambrano said it was himself, his sister Elissa Trevino, and his wife Katie Zambrano. City Attorney Shaver asked what time of day the survey was conducted. Mr. Zambrano said between 6-8 p.m. for businesses and the residential was in the

afternoons and evenings and that Elissa Trevino conducted most of the surveys for the residential area.

City Attorney Shaver asked how many refused to sign the survey. Mr. Zambrano said around 8-9.

Hearing Officer Grattan said that he would like to table this item and return to it at the end of the hearing and if Mr. Zambrano and Ms. Trevino would come up with a number of the people who would just not answer the survey.

The hearing was continued to the end of the agenda.

Mr. Dan Zambrano asked to address the Hearing Officer. He stated he wanted to let him know that he taught his kids to have respect for others and their property and would not have encouraged them to address the survey any differently. He wants to bring his kids into the family run business and is very proud of the job they have done.

Hearing Officer Grattan and City Attorney Shaver concurred to approve the change of location and change in corporate structure.

Prior to adjournment Hearing Officer Grattan and City Attorney Shaver and Ms. Peterson discussed the issues occurring when a survey of the needs and desires of the neighborhood is returned. Hearing Officer Grattan stated he does not believe there would "0" responding to the "no" question and he has seen this with other surveys. City Attorney Shaver gave examples that could be used and will draft up a written supplement to add to the survey and stating that a "no" answer and not wanting to sign the survey are two different issues.

Conchita's Mexican Restaurant, LLC filed an application with the Local Licensing Authority on July 16, 2008 for a change of location to permit sales of malt, vinous and spirituous liquors by the drink for consumption on the premises at 625 24 ½ Road under the trade name of Conchita's Mexican Restaurant. The application and supplementary documents were reviewed, found to be in order and accepted. The hearing date was set for August 20, 2008.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. The neighborhood was defined as the area bounded on the North by G Road, on the South by River Road, on the East by 25  $\frac{1}{2}$  Road, and on the West by 24 Road. The results of that survey are as follows:

1. As an owner of property in the neighborhood, an employee or a business lessee of property in the neighborhood, and/or an inhabitant who resides in the neighborhood for more than six months each year, I believe the proposed relocation will not conflict with the reasonable requirements of the neighborhood or the desires of the inhabitants.
