The regular meeting of the Grand Junction Commission on Arts and Culture was held on the above date. Chair called the meeting to order at 4:00 p.m. A motion was made by Woodrich, seconded by Reidy, to approve the minutes of the previous meeting held on January 28, 1998. No one was present to make a presentation for Very Special Arts Grand Junction (\$500).

Following the presentations, the Commission discussed the grant applications at length. A total of \$39,500 was requested from 20 groups, including a request from the Grand Junction Visitors and Convention Bureau and the Parks Department to donate \$400 toward the cost of leasing Two Rivers Convention Center for a free public concert by the U. S. Navy Sea Chanters Chorus March 18. An informal vote was taken on each application, with Commission members signifying either "yes" (to fund the proposal), "no" (not to fund the proposal), or "maybe" (undecided), or, in the case of conflicts of interest, various Commissioners abstaining from voting on specific applications. Following the informal poll and further discussion of the exact amounts of funding to donate to each project, the consensus of the Commission was to recommend to the City Council that the following grant awards be made for 1998, with \$20,000 approved in the Commission's 1998 budget for this purpose, plus \$5,000 from the Colorado Council on the Arts:
