- 21. General architectural description: <u>This is a horizontally proportioned generally</u> rectangular house with a low pitched hip roof. The main ridge runs north/south and the principal façade faces east. A shallow volume projects from the north side of the house with a hipped roof form that shares the north roof plane with the main hip form. This projecting section is covered in a dark red brick, which continues along the north, rear and south sides. The main entry is located on the south end of the main façade, adjacent to a thin brick wing wall which is the continuation of the south wall. The main roof has a deep overhang on this façade. A large horizontally proportioned window is centered on the remaining wall between the door and the shallow projection. The wall in this area is covered with a rusticated roman style brick unit, in a contrasting light color. A picture window with flanking casements is centered on the projecting wall. Two horizontally proportioned window are located on the north side and the same unit shares the south wall with another picture unit. A rectangular brick chimney is located off the main ridge to the south and west. The chimney has the same brick face as the entry wall. The house sits on a concrete base and three steps run up to the concrete landing at the entry door.

- 42. Statement of significance: <u>The development in this area is a direct result of the nation's involvement in WWII and the drive for the development of nuclear weapons. The discovery of significant sources of Uranium in the region initiated development in Grand Junction that supported both the mining of the materials and the administration of programs related to the development of weapons. The building types, materials and neighborhood layout are all indicative of the national trends which were driven by the proliferation of the automobile and the enormous demand for single family homes. House designs departed from the romantic and revival styles that were prevalent in the earlier part of the 20th century and took on a California inspired design that was characterized by simple horizontally proportioned forms. Houses were typically mass produced on previously undeveloped tracts of land at the periphery of earlier.</u>

These groups of houses were typically based on one or two plan types with a limited number of roof and exterior finish variations, further reinforcing the characteristics of mass production. In this particular subdivision there are examples of both repetitive house types and more high style individualized houses. The curvilinear street layout is characteristic of national planning trends and is unusual in this community, where new development tended to extend the existing street grid.

43. Assessment of historic physical integrity related to significance: <u>This house is generally</u> intact in its original form. Loss of some entry features has had a minor impact on the integrity. The house continues to contribute to the character of the neighborhood.

Discuss: The Bookcliff Park Subdivision lies on the periphery of the historic city center and was originally established by single group of investors. The sites were built out to accommodate the rapid growth associated with the Uranium Boom over a short period of time. The architectural styles present in the area represent a significant concentration and continuity of dwellings and a subtle transition of styles over the building period. Few intrusions have been made into the original neighborhood and it retains a high level of integrity.




