Marc Mancuso the Crew Leader at Suplizio Field/Stocker Stadium was promoted to fill in for Mike Vendegna. These positions will be held until January 1st 2009 till which all promotions will go back to their previous position. Marc Mancuso has taken on a variety of roles within the City of Grand Junction. He previously served as the

Supervisor at Two Rivers Convention Center for Building Maintenance Setup. He was also a seasonal employee with the Forestry Division.
