

ORDINANCE NO. 480

AN ORDINANCE AMENDING SECTION 1 OF  
ORDINANCE NOS. 426, 443, 455, 457, and 471,  
ENTITLED "ORDINANCE CONCERNING SALARIES"

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION,  
COLORADO,

That Section 1 of Ordinance No. 426, entitled "An Ordinance Concerning Salaries", passed and adopted the 21st day of December, A. D. 1927; Ordinance No. 443, passed and adopted December 19th, 1928; Ordinance No. 455 passed and adopted December 4th, 1929; Ordinance No. 457, passed and adopted January 2nd, 1930; and Ordinance No. 471, passed and adopted September 3rd, 1930, be and the same are hereby amended to read as follows:

SECTION 1. The following named officers and employees of the City of Grand Junction shall receive the following monthly salaries, beginning January 1st, 1931, payable at the close of each and every month, viz:
