Re: Grand Valley Irrigation Company Stock Certificates

As of this date:

Stock Certificate #22990 for 22 shares came from the Brice property. The Certificate is made out to the City and the County. In order for the shares to be included in the City's account #11541, the certificate would need to be made out solely to the City of Grand Junction. It would require Mesa County to sign the stock assignment attached to the certificate. That has not occurred. It is the only certificate held by Grand Junction that is billed separately due to it being made out to both the City and the County.

Stock Certificate # 36225 for 49 shares came from the Berry property (certificate #23009) and was originally transferred to the Parks Improvement Advisory Board. (PIAB). In August 2016, PIAB signed a stock assignment to transfer these shares to the City so that they may be included under account #11541.

Stock Certificate #19011 for 14 shares was misplaced. These shares were originally obtained from Louise Bair. A Lost instrument Bond was obtained and request for replacement was made to GVIC in June, 2017. It is to be considered for approval by the board at their July, 2017 meeting. If approved, a new certificate will be issued to the City of Grand Junction. Copies of the Lost Instrument Bond and other documentation is included herein.

## Grand Valley Irrigation Water Shares

- In 1980, PIAB purchased several properties known as Berry property and Brice property.
- There were 49 water shares with the Berry property and 22 shares with the Brice property.
- Each entity conveyed their interests in the properties to the City of Grand Junction in 1985.
- In 1994, it was decided that the properties were not suitable for park development, and voters authorized a sale in 1995.
- The Berry portion was sold to Ward Beecher and the Brice portion was conveyed to the School District. Small portions were deeded to Mesa County and all proceeds went toward the development of Canyon View Park.
- The water rights for the Berry property were retained by the City, however the stock certificate was issued to PIAB.
- The City has been paying the annual assessment (2016=\$796).
- By combining this with other accounts, the annual fee will be eliminated.
- The City will pay the required transfer and issuance fees associated with the transfer.

- City Manager, Rich Englehart, and a Grand Valley Irrigation Company representative signed the authorization of the certificates; and
- The City paid GVIC the required fee (\$20.00) necessary to accomplish the above.
- On the effective date after the transfer the assessments against the shares shall be charged by GVIC and paid by the City.
