# MEMORANDUM

SUBJECT: Trades of Water Shares

We have agreed to trade water shares with Mr. Dan Hutton.

The City needs at least 15 Juniata Ditch Company shares to be eligible to sit on the Juniata Ditch Company Board of Directors. We presently have 12 shares.

Mr. Dan Hutton has 3 Juniata Ditch Company shares but has no way of receiving Juniata Ditch water because the ditch comes in below his property.

Recommendation:

City transfers 12 shares of its Highline Ditch Company water to Dan Hutton in exchange for his 3 shares of Juniata Ditch Company water.

Juniata Ditch, Priority #11, 1 share = .042 cfs

Highline Ditch, priority #16, 1 share = .012 cfs

Outcome:

City obtains 3 more shares of higher priority water and reaches the minimum 15 shares needed to be eligible for Juniata Ditch Company Board of Directors.

The City will own 15 shares out of 500 shares of Juniata Ditch water and 1462.5 shares out of 4000 of Highline shares.

Attached is your authorization allowing Dan Vanover to sign the stock transfers to effect this trade. Please review and return to me.

Both the Juniata Ditch Company and Highline Ditch Company meetings are coming up March 22 and March 14, respectively.

Juniata Ditch, Priority #11, 1 share = .042 cfs  
Highline Ditch, Priority #16, 1 share = .012 cfs

Outcome:

City obtains 4 more shares of higher priority water. Fifteen (15) shares is the minimum needed to be eligible for Juniata Ditch Company Board of Directors.

The City will own 19 shares out of 500 shares of Juniata Ditch water and 1450.5 shares out of 4000 of Highline shares.

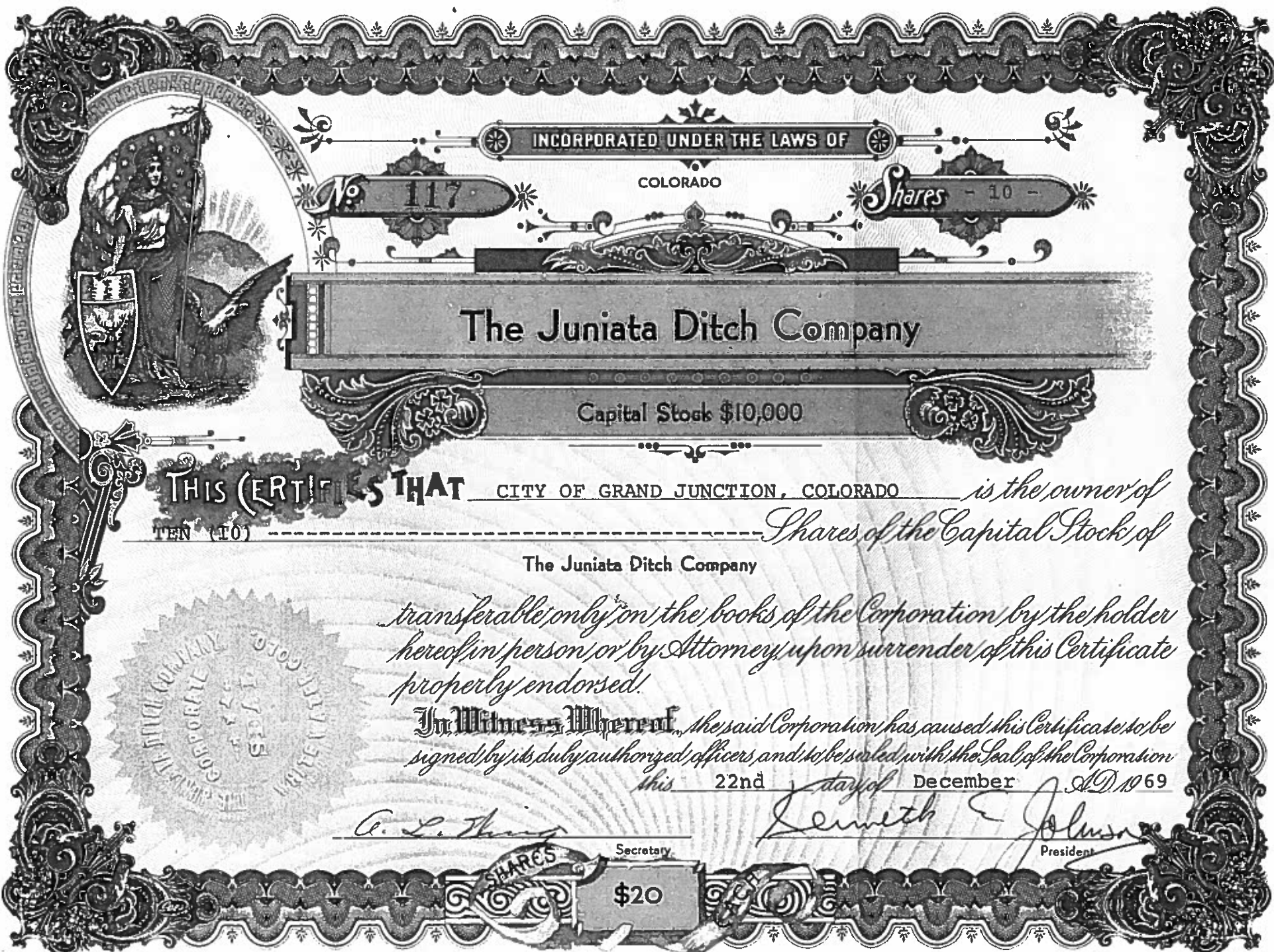

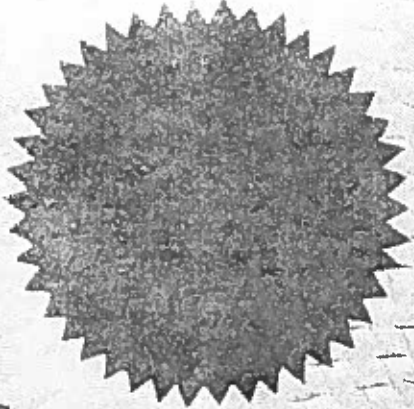
