Architectural description: Three story commercial brick building covered with metal siding. Recessed entry with large display windows and brick kickplate. Two second level windows are new with row of four smaller glass panes on either side.

Construction history (description, names, dates, etc. relating to major additions or alterations to original structure): Upper level covered with metal plating, new display windows, recessed entry, awning, second level windows—date unknown

Historic background (discuss important persons and events associated with this structure): This structure is located within the original platted area of Grand Junction

and was representative of the 1890s town building.

The 2-story building was complete by 1890, sharing a stairway and skylight with the attached building on lot 27. William Royston, apparently an "out-of-towner," may have been responsible for erecting the entire building, and be part of an Eastern Slope (Colorado Springs) investment pattern. The stone front appears somewhat distinctive for Grand Junction, where most buildings exhibit a red brick face to the world. The room upstairs served as both offices and residences over the years, although it is difficult to isolate the second-story tenants of this building from those in its other half. From 1918 through at least 1937, 516 Main was a candy store, first C.S. Miller's, then Samuel Cardman's. Upstairs (518) tenants include R.L. McGill and Charles J. Steen (later a uranium tycoon?). Music teachers are frequently upstairs tenants. The eastern half of the downstairs, 520 Main, fortuitously housed Winfield Clark Music Co., which carried a variety of musical instruments. Customers could buy instruments downstairs, then go upstairs for lessons.


