RE: Rugged Tablets and Vehicle Installation RFP-4078-15-NJ

Offerors responding to the above referenced solicitation are hereby instructed that the requirements have been clarified, modified, superseded and supplemented as to this date as hereinafter described.

Please make note of the following clarifications:

- 1. Extended Response Deadline:** The response deadline for this solicitation has been extended. Responses shall be submitted electronically as stated in the original solicitation **prior to 3:30 pm local on August 13, 2015.**
- 2. Question 25:** "Addendum 1, question 6 refers to power supplies. Please provide the specific model numbers of the installed power supplies."
Response: Most vehicles currently have a 12 V DC power adapter part# BK 7821635 as well a ChargeGuard timer part# CG-X, the awarded contractor will only need to use the power available at the dock that is provided by the ChargeGuard.
- 3. Question 26:** "In addendum 1, question 10, the actual question is not answered yes or no. While it is clear that things should have a 4 year term, do you actually want the Protection Plus (no fault) warranty?"
Response: Yes, please quote with a 4 year no-fault warranty.
- 4. Question 27:** "In addendum 1, question 14, the answer requires pass through connections. What signals would you like to pass through?"
Response: Please provide the options available as part of your proposal.
- 5. Question 28:** "In addendum 1, question 19, the term "best mount" is used. Please provide a detailed explanation of "best mount". That term is ambiguous."
Response: Pictures of the current mounting systems are attached to Addendum 1 to this solicitation. Depending on the proposed tablet, different mounts may be utilized, best mount can be interpreted as proposers 'recommendation'.
- 6. Question 29:** "In addendum 1, question 24, the specific model numbers are requested. The answer does not provide specific model numbers, just types of computers (CF30 and CF31)

the model number are in the format of CF-31XXXXXXX (with the "X" representing various numbers and/or letters). Please provide the specific models."

Response: We have many different models of the CF-30's and CF-31's, this information shouldn't be needed as we are requesting Ruggedized tablets, which will change the current docking stations

7. **Question 30:** "Based on the responses to addendum 1, please extend the deadline of the response one week to August 18th."

Response: The response deadline will be moved to August 13th, 2015 prior to 3:30 PM Local.

The original solicitation for the project noted above is amended as noted.

All other conditions of subject remain the same.

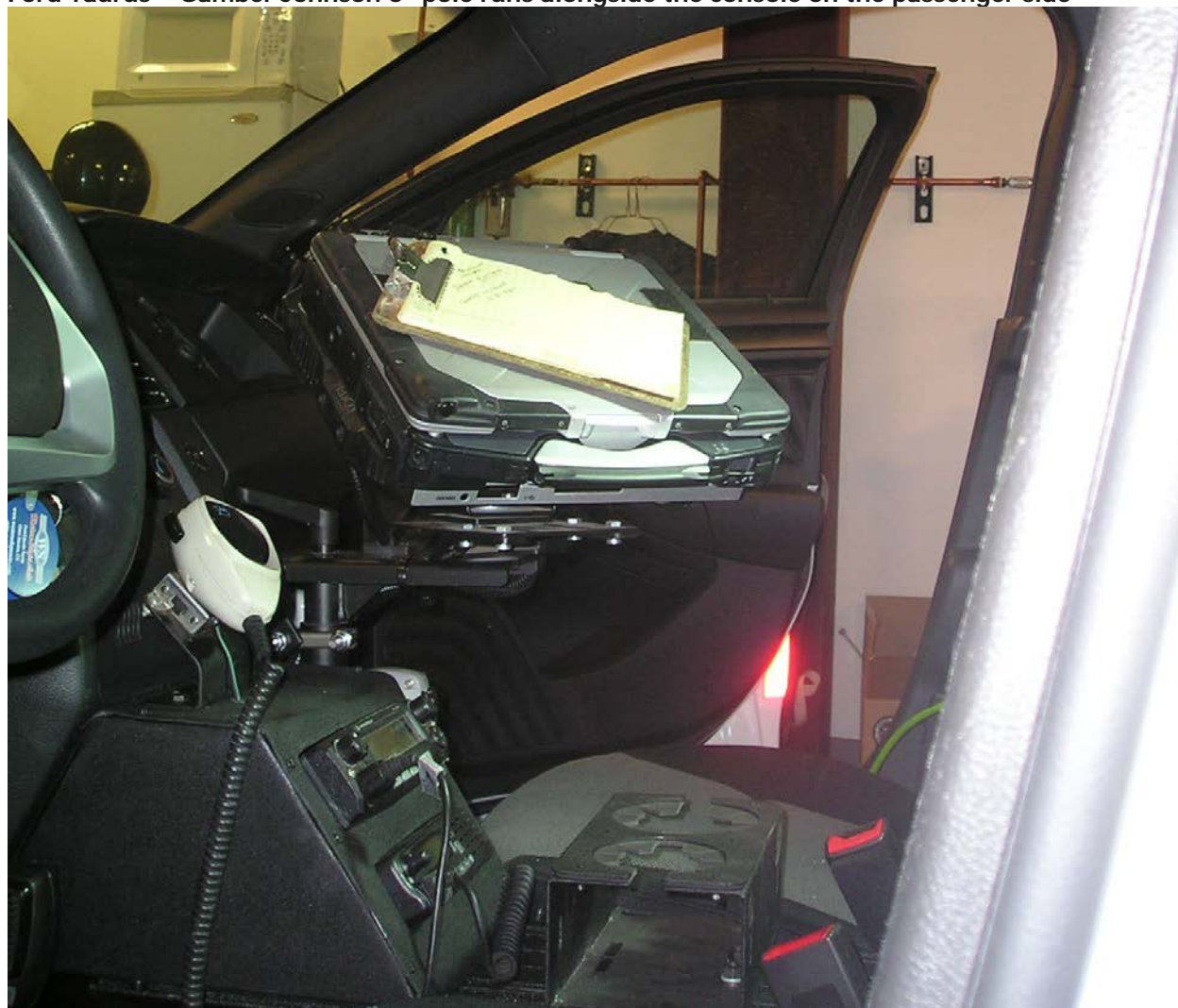
