Effective August 3, 2007, there will be an increase in the City of Grand Junction's liquor and beer fees as follows:

Application fees for a new, transfer of ownership, and transfer of location for a liquor or beer license will increase from \$500 to \$625.

Application fees for renewal of a liquor or beer license will increase from \$50 to \$75.

Application fees for a special events permit for both malt, vinous, and spirituous liquors and fermented malt beverage will increase from \$0 to \$100. This is a new fee. The permit fees remain the same (\$10/day for 3.2% beer and \$25/day for malt, vinous, and spirituous).

Any of the above applications received in the City Clerk's office **prior** to August 3, 2007 will be charged at the current rates.

Any of the above applications received in the City Clerk's office **after** August 3, 2007 will be charged at the new increased rates.

**Also**, please be advised that as of July 1, 2007, the State Liquor Enforcement Division is reducing its fees. Therefore, any application received in the City Clerks office after that date will be subject to the following reductions:

- Application for a new license will be reduced from \$1,125 to \$1,025
- Application for a new license w/concurrent review will be reduced from \$1,225 to \$1,125
- Application for License Transfer will be reduced from \$1,125 to \$1,025
- Application for license transfer w/concurrent review will be reduced from \$1,225 to \$1,125

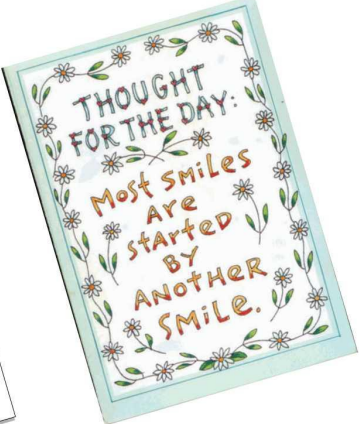
