Can your Establishment Pass a Compliance Check?



As a licensee, you are probably aware that the local police department and Colorado liquor enforcement officers periodically conduct compliance checks.

What should you the licensee do to prevent selling alcohol to a minor and the subsequent liquor code violation and possible suspension or revocation of your license? Some suggestions:

- Always check every customer's identification
- Be aware of what driver's licenses look like for minors. Licenses for minors clearly state "under 21" in bold red and are portrait-style or vertical, rather than horizontal.
- Know how to tell what a false I.D. looks like. Licensees are permitted under C.R.S. 12-47-901 (5)(a)(II) to confiscate suspected false or fraudulent identification. Confiscated identification must be turned over to a state or local law enforcement agency within 72 hours. The following methods can be used to assist in detecting false IDs:
 - 1. Ask for a second piece of identification.
 - 2. Put a flashlight behind a Colorado driver's license to spot alterations.
 - 3. Check for an extra layer of lamination.
 - 4. Look at both sides of an ID for alterations.

The following forms of identification are valid forms and include a photo and a description of the bearer.

- 1. An operator's, chauffeur's or similar type driver's license containing a picture issued by any state.
- Identification card containing a picture issued by any state for the purpose of proof of age in accordance with C.R.S. 42-2-402.
- 3. Military identification card.
- 4. Passport.
- 5. Alien registration card.

IS YOUR LICENSE UP-TO-DATE?

Each year when you file your liquor or beer renewal application that you received from the State, you must complete a question on the form that pertains to the expiration of your lease. Your lease must be effective through the term of your liquor license. If your lease has been renewed, amended, or extended, two copies of the lease documents need to be submitted to the City Clerk's office. The City Clerk's office will submit one copy to the State Liquor Enforcement Division with the renewal.
