New alcohol law initiative strives to improve enforcement

The National Center for Alcohol Law Enforcement is a new federal initiative funded by the Bureau of Justice Assistance, Office of Justice Programs, US Department of Justice. NCALE's mission is to increase and improve enforcement of current alcohol laws that are most likely to reduce alcoholrelated crime, injury, and violence.

The center aims to accomplish this by providing training and technical assistance to advance local officers' understanding and expertise in alcohol law enforcement and facilitate effective collaboration between state alcohol beverage agencies, local law enforcement agencies, and other law enforcement agencies. Successful enforcement of laws related to sales to intoxicated persons, sales practices that encourage intoxication, public nuisance standards applicable to problem establishments and underage consumption will improve the quality of life in any community and reduce many other alcohol-related crimes that law enforcement often has to deal with.

It is well known that alcohol problems constitute a major public -safety risk in the United States. For example:

- Approximately 85,000 Americans die each year from alcohol-related causes.
- : Among America's 11.1 million victims of violent crime each year, one in four report that the perpetrator had been

- drinking before committing the crime.
- : In 2003 alone, 40 percent of all traffic crash fatalities and 7 percent of all crashes involved the use of alcohol. This resulted in 17,013 deaths and 275,000 injuries related to alcohol consumption.

The successful enforcement of alcohol beverage laws has tremendous potential to save lives and prevent injuries that are often the consequences of harmful drinking behavior, NCALE believes that providing state and local law enforcement agencies and regulators with the necessary training and technical advice to enforce current alcohol beverage laws helps achieve these goals. Almost all NCALE services are provided at no cost to state or local governments.

NCALE provides customized training to state and local government in areas such as enforcement of sale to intoxicated laws, nuisance bar enforcement, detection of fraudulent identification, source of alcohol investigations, administrative license case preparation and prosecution, enforcement of underage drinking laws, and other specialized training needs in alcohol enforcement.

NCALE also provides technical assistance related to: working with licensed establishments and regulatory agencies on responsible vending practices; acquisition of model statutes and ordinances; Continued on next page
