Tavern and Hotel/Restaurant Licenses

Reducing Restrictions on Ownership

Recently, the legislature passed House Bill 03-1337 (HB-1337), which was signed by the governor in May 2003. This Bill amends the multiple-ownership prohibition for two types of retail licenses: tavern licenses and hotel and restaurant licenses (found in sections 411 and 412 of the Liquor Code). The new language affects retail licensees in that it removes certain limitations placed on individuals who own, or wish to own, multiple tavern and/or hotel and restaurant licenses. Now an individual with an interest in a tavern license can also hold an interest in a hotel and restaurant license and vice-versa. Also, a person may now own an unlimited number of tavern, hotel and restaurants, or both.

New State Law Concerning Credit

This legislative session, passed an amendment to the Colorado Liquor Code, 12-47-2002 (2)(b)(II), requiring all licensees to comply with federal regulations prohibiting the extension of credit for the sale of alcohol beverages beyond thirty days.

Federal regulations state that the "extension of credit by an industry member to a retailer for a period of time in excess of 30 days from the date of delivery constitutes a means to induce (product selection) within the meaning of the Act".

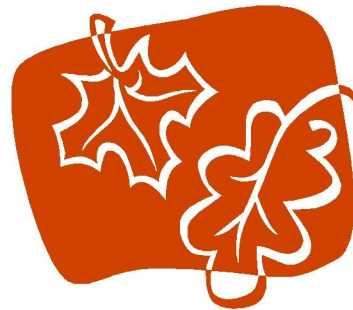
