

On March 26, 1999, Ordinance 3095 went into effect regulating the sale and use of tobacco products. The purpose of the ordinance is to limit access to tobacco products by minors. Specifically, tobacco sales are limited in the following ways:

ORDINANCE

3095

- Sale of tobacco products by vending machines is limited to only places that are not open to the public, such as factories or businesses; or places to which minors are not permitted access. For example, a bar that serves only alcoholic beverages and does not permit minors at all, could have a vending machine in its establishment, while a restaurant/bar could not.
- Minor employees of establishments that sell tobacco products are prohibited from selling the tobacco products.
- Any self-service displays of tobacco products are prohibited, with the following exceptions:
 - In stores which have a valid retail liquor license; or
 - 2. In vending machines which are permitted according to Section 1, above.
- Any establishment that sells tobacco at retail must display a warning sign notifying the public of the penalties to minors purchasing or possessing tobacco products. The ordinance specifies the size and type of sign that must be displayed.
- ♦ Sale of single cigarettes or packs of cigarettes containing less than 20 cigarettes is prohibited.

The penalties for violation of this ordinance are fines of up to \$50 for the first offense; up to \$100 for the second offense; up to \$500 for the third offense; and up to \$1000 for each subsequent offense, as well as up to 1 year in jail.

10 Commandments for Serving Alcohol

- 1. Thou shalt not serve alcohol beverages to anyone under 21 years of age.
- 2. Thou shalt check the ID of anyone that appears to be 30 years or age of younger.
- 3. Thou shalt only accept pictured state-authorized IDs as proof of age.
 - Valid and pictured state-issued drivers licenses.
 - b) Valid and pictured state-issued identification cards.
 - c) Valid and pictured military IDs.
 - d) Valid and pictured passports.
 - e) Valid and pictured alien registration cards.
- Thou shalt not serve anyone who appears to be intoxicated.
- Thou shalt not let customers leave the premises with alcohol.
- 6. Thou shalt observe all state regulations concerning hours of operation.
- 7. Thou shalt not handle customer confrontations alone. (Solicit the assistance of management and/or law enforcement, but not customers.)
- 8. Thou shalt not serve employees alcohol without management authorization.
- 9. Thou shalt not allow gambling on the premises.
- 10. Thou shalt observe ALL of the above nine commandments!

What is Happening in---Rifle

After 3 months of debate and discussion, Rifle City Council recently passed an ordinance that amends underage possession and consumption of regulations. alcohol This ordinance adopts less а stringent definition of "possession" than state statute; "possession" means a person has or holds any amount of alcohol anywhere on his or her State statute extends person. the definition of possession to include alcohol that is in the "immediate presence and individual. control" of an Because of this discrepancy, the Rifle Police Chief voiced strong opposition to this ordinance (as you can imagine, local teenagers supported it). Council will revisit this issue in a year to determine the effectiveness of the new regulations.

Regulation Change

Regulation 47-301. Undue Concentration of Licenses. was created in response to the application (or application) of the statutory provisions of 12-47-301(2)(b) C.R.S., which allowed Local Licensing Authorities to deny a new Tavern or Retail Liquor Store license if issuance of a new license would result in an undue concentration of that class of license, and require the additional of law use enforcement resources. The Regulation provides guidance to help determine what constitutes an "undue concentration" and use οf "additional enforcement law resources."

House Bill 99-1065 Regarding Club Licenses

For club licensees who are filing a change in corporate structure, this new House Bill affects Regulation 12-47-307 and reads. "(II) With respect to club license applications by corporations only, an investigation of the character of the corporate president and the club manager shall be deemed sufficient to determine whether to issue the club license to the corporation. " This means club licensees who change corporate officers each year will still need to report the changes but, individual histories and fingerprint cards will ONLY be filed when the president and/or manager changes.
