## ORDINANCE NO. 520

## AN ORDINANCE CONCERNING SALARIES AND TO REPEAL ALL FORMER ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:
