Gentlemen:

Enclosed please find a copy of the permit issued under the Federal Water Pollution Control Act and Colorado Water Quality Control Act.

Issuance of this permit constitutes a final determination of the Division of Administration of the Colorado Department of Health, in conjunction with the U.S. Environmental Protection Agency and may be subject to administrative review proceedings pursuant to the State Administrative Procedure Act, including an adjudicatory hearing. You are advised to consult this act and particularly to consult Sections 24-4-104, 24-4-105, 24-4-102(7), and 25-8-401, C.R.S. 1973 for more information. In addition, the Regulations for the State Discharge Permit System contains material that is pertinent to any administrative review of the issuance of this permit.

Your NPDES Waste Discharge Permit requires that specific action be performed at designated times. Failure to meet these requirements constitutes a violation of this permit and can result in civil and/or criminal action(s). Please read the permit very thoroughly.

1. All municipal and industrial facilities are required to submit self-monitoring information. (PART I. B. Monitoring and Reporting). Frequencies and types of self-monitoring are summarized in PART I A. Effluent Limitations and Monitoring Requirements.
2. Monitoring and reporting requirements for feedlots are described in PART I.
  - A. Effluent Limitations and Monitoring Requirements (see 2. c.) and in PART I.
  - B. Monitoring and Reporting.
3. In some instances a schedule of compliance is to be submitted if required by your permit. Please note the required date as specified in PART I of the permit.

4. PART II A. Management Requirements and B. Responsibilities, contains information that explains further requirements which are enforceable as are all other provisions of the permit.
5. PART III Other Requirements specify certain reports that are required and/or notifications that are necessary.

Please read very carefully the enclosed memorandum regarding annual NPDES permit fees.

MEMORANDUM TO PERMITTEES

The 1975 session of the Colorado Legislature amended the Colorado Water Quality Control Act to provide for annual NPDES permit fees. The amended Act provides a fee schedule based on the size and type of facility. Your facility is classified as Major Municipal and the annual fee is \$250.00. These fees will be collected annually at the beginning of each fiscal year and the entire annual fee is to be paid at that time. Facilities receiving their first NPDES permit to discharge will be billed at the time of issuance for the remainder of the fiscal year.

- Since this facility had an active NPDES permit prior to July 1 of this year, a bill has previously been sent for this fiscal year.
- Since this facility did not have an active NPDES permit prior to July 1 of this year, the fee for the remainder of this fiscal year is and should be forwarded to the office within thirty (30) days after the date of receipt of this letter and your permit. Make checks payable to the Colorado Department of Health, Discharge Permit Fee.
