A situation seems to be developing that either needs to be corrected by some clarification of policies, coordination, and cooperation between your department and my department, or I need to make a statement as to the attitude of my staff and myself regarding the present method of operation as it relates to the review and approval of proposed developments outside the City.

It is my understanding, and I think you made the statement yourself in a public meeting on February 23, 1977, that it is policy for the City Public Works Department to review proposed development plans that are within three miles of the city. I see this as a courtesy service to the County Planning Commission and County Commissioners since the County does not have an engineering staff. I don't mind my staff spending time on these reviews even though they have more than enough work involving projects within the city. As a matter of fact I consider it to our mutual benefit that the City be allowed a chance to review "outside" projects. I think we both agree that an arbitrary city limit line does not separate areas of influence or concern.

My concern today is that the above policy is not being followed consistently. My fear is that if the policy is not followed consistently that your department is likely to be accused of being arbitrary and capricious if not fraudulent. I certainly do not want my department to be in a position of being accused of being a party to that type of operation.

Let me be a little more specific as to why I believe this situation is developing. An example is the Clifton Village Subdivision. This development as I understand it (plans have never been submitted to my department even though this is within three miles of the City) contains some rather drastic changes in design concepts from what has been predominant in this area in the past. For example: streets, lot sizes, set backs, etc. Because of these changes I would assume that the County Planning Commission would be interested in engineering staff comments. At the February 23 City Planning Commission this development plan was presented for review and comment. At that meeting Ron Rish made the comment that he had not seen the plan. You said that it was an oversight, however to this date my department has still not received a set of plans to review. This item was presented to the County Commissioners yesterday for their action. Duane Jensen was present at the meeting, more so as an interested party who lives in the area than as a city engineer. Duane made some comments but he feels that they were not taken seriously and that you as Development Director tried to deal with or answer his comments in an effort to "write them off" rather than leaving that up to the County Commissioners. that the whole thing looks like a "railroad job" to my department. I certainly hope I am wrong about this but I think it only fair to let you know how we are beginning to feel. The only way that we can resolve our differences is to find out what our differences are.

We have noticed in the past where there were items on the agenda that we never had a chance to review. Maybe these were oversights or maybe you would say that they were not significant items. We feel that the only way that we can work with your department in good conscience is to review all proposed developments as objectively as we can. To review some and not review others puts us, we feel, under a shadow of doubt, a condition under which we do not want to work.

We would like to continue to provide this service to the County, but unless we can provide it in an ethical manner we will have to decline from offering review and comment on any of the items.
