Attached is a copy of additional sewer line problems located in your district. There may be some repetition with the original list sent you on 10-7-81.

I also feel a brief comment is in order relative to your letter dated 10-13-81. In that letter, two problems were addressed by the Board of CGVSD. One referred to overloaded lines being referred to your contractor. The second problem referred to maintenance of existing manholes and that you will "have a record sent to Fred Bishop and instruct Fred to maintain the manholes as per your city listing". Although not specifically mentioned in the letter, I hope your intention would be to also provide a record of sewer line (and additionally, manhole) locations to the City of Grand Junction so that in the event of a sewer back-up we can locate the backed-up lines on a more immediate basis than having to locate Fred Bishop.

I would also like to reiterate the need for full access through right-of-ways to facilitate line flushing and maintenance.

Finally, please have the Board of Directors or yourself contact Jim Patterson for the prupose of appointing an agreed upon construction inspector for all future development.

Re: Additional Problem Areas in Central Grand Valley Sewer Systems

- 1. 29 Road between D½ Road and I-70 Bypass line is overloaded and manhole at D&RG RR tracks is buried.
- 2. 30 Road and Hill Ct. excessive infiltration.
- 3. 31 Road and D Road line is overloaded.
- 4. 29 Road and Florida Dr., no manhole at end of sewer
- 5. C¹₂ Road and 27¹₂ to 29 Road, line is overloaded.
- 6 532- 29 Road, building on top of sewer line
- 7. 29 Road & D_2 , line is overloaded and manhole is in bad condition.
- 8. 30 Road and E Road to 304 and E Road, manholes are buried.
- 9. Dig and 30 Road east, map does not show new manneles.
- 10. 2972 Dig Road, line is overloaded and manhole is in bad condition.
- 11. 3007 Hill Ct., pipe is not cut out of manhole, water is standing in same manhole.
- 12. East of 30 Road on north side of Grand Valley Cannal, apparent infiltration and manholes on east end of line where line turns northeast are under water. Check on line per sheet 11-11a-12, also check sheet 63-64.
- 13. 532 Teco, south of 533 Dodge, manhole buried.
- 14. 29 Road from Grand Valley Canal south, the line is overloaded or appears to be.
