After study, Cope's recommendation was that land application was not feasible here. Commissioners decided to delay their decision for an additional two weeks for further consideration of public input.

Additional information arising out of this meeting was: a plant site of I-70 and 22 Roads had been identified and "had been accepted by the community, the City Council and the County

Commissioners." The City has an option on the land of the proposed site. The price was at fair market value.

Patterson's remarks included a statement that if the County did not approve the Mechanical Treatment Plant, the City would be left with three options: (1) Proceed with the plant as proposed as a City plant only. "The burden of decision-making would then be with the City Council." (2) The City could pursue the land application project. (3) The City could retain its present plant and develop it as the City's own plant for its sole use.

If either options 2 or 3 were selected the City would have to deal with strict capacity regulation and would probably disallow any more taps in Central Grand Valley, Fruitvale, Paradise Hills or Orchard Mesa. Patterson suggested that if the City did not take this action, the State Water Quality Control Commission might. The result would be development of multiple sewer districts and more package treatment plants which "would force larger amounts of land into residential use." [Commissioners Minutes]

County Commissioners hold a public hearing concerning the recommendations of the Valleywide Sewer System Committee. Prior to this meeting, the Committee had met and reaffirmed its vote recommending the Mechanical Plant proposal, and the Mesa County Planning Commission had met and recommended that the Commissioners accept the Mechanical Plant proposal. Jim Patterson, on behalf of the Committee, presented the Committee's recommendation for the Mechanical Plant proposal. Ed Carpenter spoke in opposition to that proposal.

Commissioner and Committee Member Roland, during the hearing, stated: the need for the new sewer treatment plant came from "a bad situation in regard to sewage" in the valley. Seventy-five percent of the cost would come from the Federal Government with the remainder "from revenue which is not taxable and financed by the users." Planner McDonough remarked that the location of the plant "does not necessarily mean that all of the land between and within the 201 boundary or between the City of Grand Junction and the plant location will be approved for immediate development on the arrival of the new plant. The Planning Commissions are very definitely looking towards a managed growth policy and graduated growth."

Commissioner Snider commented: In regard to multi-districts, many agencies frown on too many sewer districts. Multi-districts "cause a lot of problems." He asked "if somebody lived in a remote area and wanted to hook on to the sewer, would his fees for the lines be higher or would the treatment costs be the same for everybody?" McDonough said that it would be the same. He asked "if a sewer district wanted to hook on to the sewer, would it still cost the same to the end user for the treatment charge?" McDonough said that it would be the same. He commented that "due to lack of capacity, the City of Grand Junction could refuse to provide sewer facilities to residents outside of the City limits; that the City of Grand Junction could build a smaller plant on its own, that the County might have to build a plant on its own." He wondered if the County ever got to the point of feeling unduly pressured by the Federal Government, could it return the EPA grants? He was told that the "Federal Government controls are already in effect through certain laws that any municipality has to abide by in regard to sewer regulations."

County Administrator Ford stated that the County should somehow go on record "as to letting the people who are building this plant know that the County is in <u>desperate</u> need of a place to take care of the septic waste from individual homes and he hopes that this can be worked into the plan so that when the plant goes on line this matter can be taken care of."

County Commissioners voted unanimously to accept the recommendation of the Valleywide Sewer Committee including the recommendation that further alternatives be studied. [Commissioners Minutes]
