A white canvas awning with blue trim is across the front of the building. Canvas awnings are also over the windows on upper level. There are small wood frames with glass used for display on either side of the entry. A small bracketed cornice is on second level and decorative work at the top of the building with the word "Kress"in a stepped parapet. Large lettering appears across the front above the lower awning.

historic background (discuss important persons and events associated with this structure) This structure is located within the original platted area of Grand Junction and was representative of the 1920s town building. S.H. Kress & Company occupied the building from 1929 until 1973.

Around 1929, the present building was constructed by the nationwide Samuel H. Kress chain to house a 10-cent and "notions" store. The building was originally laid out with a selling floor, basement, warehouse, and office mezzanine. Renamed the Mercantile in 1975, it has been extensively remodeled by subsequent owners. Current occupants include Main Page, a designer fashion store.
