architectural description: Two-and-one-half story, rectangular, frame, Queen Anne house; intersecting hip and gable roofs with asphalt shingles; turret on west end of building; gable dormer in attic has two 3/3/3 windows; small second story balcony on front of building with wrought iron railing; turret is surrounded by 1/1 windows at the second story level and by fixed glass windows with one pane at the third story level; covered porch wrapping around entire front and east sides of building; first floor windows are 1/1; wood siding; front sidewalk leads to concrete steps that lead to porch; wood shingles cover the raised foundation; porch roof is supported by short doric columns, which stand on a shingle-covered stem wall; shrubs, trees, and grass.

George Crawford selected the town site on Sept. 26 1881, incorporated the Grand Junction Town Company, and platted a section of land for town development in typical grid fashion. Boundaries were established at North and South avenues and First and Twelfth streets. Corners were set aside for churches, blocks for school buildings (between Fifth and Sixth streets and White and Rood avenues), parks - Maple, Walnut Chestnut, and Cottonwood (names later changed to Whitman, Emerson, Hawthorn, and Washington, respectively)- were designed for each quarter section of the original town plat.
