Two-and-one-half story, square, frame house; hip roof with asphalt shingles; gabled dormers on front and west sides of roof; 15/1 wood frame windows on east and west front ends; front dormer has 1/2 circle fixed window over three 1/1 windows in a Palladian style; center front of building 1/1 window with transoms on either side; covered front porch supported on domic columns; porch runs the entire width of building with concrete steps leading to it; the facade is a symmetrical composition. The entry is centered on the first floor. Above, on the second floor a set of three windows is flanked by paired collonettes. A metal fence surrounds the lawn which has shrubs and trees.




George Crawford selected the townsite on September 26, 1881, incorporated the Grand Junction Town Company, and platted a section of land for town development in typical grid fashion. Boundaries were established at North and South Avenues and First and Twelfth Streets. Corners were set aside for churches, blocks for school building (between Fifth and Sixth Streets and White and Rood Avenues), parks - Maple, Walnut, Chestnut, and Cottonwood (names later changed to Whitman, Emerson, Hawthorn, and Washington, respectively) were designed for each quarter section of the original town plat. This structure is located within the original platted area and is representative of the 1890s town building era. architectural significance:
