I. CALL TO ORDER

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Mike Grattan, City Attorney John Shaver, and Deputy City Clerk Debbie Kemp.

II. APPLICATION TO RENEW LIQUOR AND BEER LICENSES

Alan and Thelma Allen, owners of TJ's Billiards, were present.

The application for renewal for TJ's Billiards, LLC dba TJ's Billiards was found to be in order and approved.

No one was present representing the applicant.

No one was present in opposition of the change in corporate structure.

City of Grand Junction – Parks and Recreation Department, 1340 Gunnison Avenue, Grand Junction, CO 81501 – Brews and Thunder Cars Show, August 28, 2015, 4:00 p.m. to 11:00 p.m., 1340 Gunnison Avenue, in the fenced practice field east of Suplizio Field, and August 29, 2015, 10:00 a.m. to 5:00 p.m., 1340 Gunnison Avenue, in area south of Lincoln Park Barn

Larry Manchester, Recreation Supervisor for the City of Grand Junction and the Event Manager, was present.

Ms. Kemp advised that there were two applications filed for the event because there are two separate locations being requested for alcohol service.

City Attorney Shaver handed Mr. Manchester four documents, the first two marked with an A in the upper right hand corner, the third page marked with a B1, and the fourth page marked with a B2. He asked Mr. Manchester what document A is. Mr. Manchester said it is a Special Event Permit Questionnaire and Affidavit. City Attorney Shaver asked Mr. Manchester if he has personal knowledge of the document. Mr. Manchester said he did because he is the one that filled out the document. City Attorney Shaver asked Mr. Manchester to explain what the application relates to. Mr. Manchester stated that the Friday. August 28, 2015 portion of the event is a free musical concert for the community which will take place in the practice field area behind Suplizio Field. City Attorney Shaver asked if Exhibit B1 is the diagram indicating where that portion of the event will take place. Mr. Manchester said yes. City Attorney Shaver asked what the black line on the diagram indicates. Mr. Manchester stated that it represents permanent fencing which allows for a secure area. City Attorney Shaver asked how many security personnel will be at that portion of the event. Mr. Manchester stated there will be eight paid security and eight City Staff that will monitor the ingress and egress so that no alcohol goes in or goes out and they will monitor the activity of the guests on the inside of the fenced area. City Attorney Shaver asked Mr. Manchester what direction will be given to security relative to compliance with Colorado law. Mr. Manchester stated that City Staff has been through the City's liquor training so they know what to watch for. It is a public event so any age will be allowed at the event but patrons 21 years and older who want to purchase alcohol will all be wrist banded and Mr. Manchester will instruct security personnel and City Staff that anyone consuming alcohol without a wrist band will have to be addressed appropriately.

City Attorney Shaver asked Mr. Manchester if this event has been held in the past. Mr. Manchester said the event is a brand new event. City Attorney Shaver asked Mr. Manchester to describe his experience in hosting similar events. Mr. Manchester stated that he has been an event manager for Southwest Arbor Fest for 15 to 20 years, Colorado Porks and Hops for going on nine years, and he is the liquor manager for the Lincoln Park Sports Complex. City Attorney Shaver asked Mr. Manchester if there have been any notable problems with previous events at the park. Mr. Manchester stated there has not.

City Attorney Shaver asked Mr. Manchester if the information contained in Exhibits A and B1 are true and accurate to the best of his knowledge. Mr. Manchester replied affirmatively.

City Attorney Shaver asked Mr. Manchester what the expectations of the event are for Saturday, August 29th. Mr. Manchester stated that it is the car show and craft beer tasting portion of the event in the loop area at the park. He described Exhibit B2 and stated that the black line will be the fenced area. There will be food vendors and 100 to 125 cars in the car show and people could enjoy a beer while they walk around and look at the cars. City Attorney Shaver asked if the same practices for the service of alcohol as mentioned previously will be used. Mr. Manchester said yes. City Attorney Shaver said that the questionnaire and affidavit indicated that there would be four paid security personnel and eight City Staff and he asked if that is a minimum amount of security. Mr. Manchester confirmed that to be right and said that there will actually be more City Staff present to watch for activities. He said that they anticipate a much smaller crowd and more of a family oriented crowd than what they expect to see on Friday.

Hearing Officer Grattan asked what type of fencing will be used as indicated on Exhibit B2. Mr. Manchester stated that it will be snow fencing.

There was no one present in opposition to the applications.

Hearing Officer Grattan admitted Exhibits A, B1, and B2 into the record (see attached) and noted that only one questionnaire was being submitted as evidence since they both were for the same event and the only difference between the two were the number of security at the event. He found that pursuant to Colorado State Statutes 12-48-106, there are no grounds to deny the special events permits on the basis that they would be injurious to the public welfare, the nature of the special events (a concert and a car show seem appropriate), their location within the community (events are approved at Lincoln Park all the time), or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found that both of the applications for special events permits submitted by the City of Grand Junction for the Brews and Thunder Cars Show were in order and approved them.

Larry Manchester, Recreation Supervisor for the City of Grand Junction and the Event Manager, was present.

Ms. Kemp advised that there were two applications filed for the event because there are two separate locations being requested for alcohol service.

City Attorney Shaver handed Mr. Manchester four documents, the first two marked with an A in the upper right hand corner, the third page marked with a B1 which refers to the area for September 11, 2015 in the fenced practice field east of Suplizio Field, and the fourth page marked with a B2 for September 12, 2015 in the area south of Lincoln Park Barn. He asked Mr. Manchester to describe what is being proposed for the event for September 11th and 12th. Mr. Manchester said that the area by the practice field for the evenings of September 11th and 12th will be a musical venue for the Porks and Hops Challenge. There will be food vendors and a stage set up for musical entertainment in that area. The black line on the diagram indicates permanent fencing with one entrance and exit where the paid Staff will be checking bags to make sure no alcohol goes in or goes out of the event. Identification checkers, token sellers, and the beer area will be monitored. City Attorney Shaver confirmed with Mr. Manchester that according to Exhibit A, he expects the attendance to be 5,000 people and asked how he came up with that number. Mr. Manchester confirmed that would be for both days and they came up with that number by looking at the ticket sales from the past eight years. City Attorney Shaver asked Mr. Manchester if he has been involved with this event for all of the past years. Mr. Manchester said he has. City Attorney Shaver asked if there had been any problems during the event over the past years. Mr. Manchester said not to his knowledge. City Attorney Shaver asked Mr. Manchester to describe Exhibit B2 which is the beer garden area south of the barn. Mr. Manchester said, in that area, there will be a people's choice National barbeque tasting competition that is sanctioned by the Kansas City Barbeque Society where teams across the country will compete for \$20,000 in cash prizes. During this event, the teams will be judged by certified judges and will earn points to qualify to go to the National competition. In the past, people had made comments that they would like to be able to have a beer in that area, so this will be the first time for that. It is a confined smaller area and will have a minimum of two paid security personnel and eight City Staff. City Attorney Shaver asked if the alcohol is an accessory or adjunct to the event and the event isn't all about the alcohol. Mr. Manchester said that is correct.

There was no one present in opposition to the applications.

Hearing Officer Grattan admitted Exhibits A, B1, and B2 into the record (see attached) and noted that only one questionnaire was being submitted as evidence since they both were for the same event and the only difference between the two were the number of security at the event. He found that pursuant to Colorado State Statutes 12-48-106, there are no grounds to deny the special events permits on the basis that they would be injurious to the public welfare, the nature of the special events (similar to the event approved previously), their location within the community (appropriate), or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found that both of the applications for special events permits submitted by the City of Grand Junction for the Colorado Porks and Hops Challenge were in order and approved them.

Craig Glogwoski, Executive Director for the Community Hospital Foundation, was present.

Hearing Officer Grattan disclosed that he has in the past participated and supported this event and asked if there is any conflict with him hearing this matter. City Attorney Shaver advised that there was no conflict.

City Attorney Shaver handed Mr. Glogwoski three documents, the first two marked with an A in the upper right hand corner, and the third page marked with a B. He asked Mr. Glogwoski if he has personal knowledge of the documents. Mr. Glogwoski said he did because he filled them out. City Attorney Shaver asked Mr. Glogwoski how he is connected to the event. Mr. Glogwoski said that he is the Executive Director for the Community Hospital Foundation for Community Hospital and the event is a community event with a fundraising aspect to it. The profits are given away to COPMOBA for trail building, CMU cycling scholarships, etc. City Attorney Shaver asked how many years the event has been occurring. Mr. Glogwoski said this will be the 27th year. City Attorney Shaver asked Mr. Glogwoski how many of those years does he have personal knowledge of the event. Mr. Glogwoski said two years. City Attorney Shaver asked Mr. Glogwoski if there had been any problems with the event the last two years. Mr. Glogwoski said there has not. City Attorney Shaver asked Mr. Glogwoski to describe the location for the event. Mr. Glogwoski said it is in the northeast parking lot at Canyon View Medical Plaza on 24 Road by Canyon View Park, where the new Community Hospital is being constructed. City Attorney Shaver asked if that location has been depicted on Exhibit B. Mr. Glogwoski said yes. City Attorney Shaver asked Mr. Glogwoski to describe what is on the diagram. Mr. Glogwoski said that the area shown in red will be the roped off area for the beer garden and within that area will be

where the alcohol sales and consumption will occur. Staff and volunteers will monitor to make sure no one leaves that area with a beer in their hand. Mr. Glogwoski said that also shown on the diagram is an enlarged area for the beer area itself. Kannah Creek Brewery and Palisade Brewery will be checking identification, wrist banding persons 21 and older, and pouring the beer. City Attorney Shaver asked how Mr. Glogwoski, the applicant, will ensure that the checking of identification will be done properly. Mr. Glogwoski said that, as he did last year, he will stand there and watch the checking of the identifications. City Attorney Shaver asked about the number of people expected at the event. Mr. Glogwoski said that they anticipate 475 people, approximately the same amount as the event last year. City Attorney Shaver asked whose signature is on the second page of Exhibit A. Mr. Glogwoski said it is his. City Attorney Shaver asked if, by that signature, does he represent that the information on the document is true and accurate. Mr. Glogwoski replied affirmatively.

Hearing Officer Grattan asked what Mr. Glogwoski meant by the area being roped off on Exhibit B. Mr. Glogwoski stated that it will be roped off with caution tape (crime scene yellow tape). Hearing Officer Grattan asked how they will prevent people from penetrating or busting down that barrier. Mr. Glogwoski said they will have one paid uniformed security guard and approximately 20 to 40 volunteers monitoring the area.

There was no one present in opposition to the application.

Hearing Officer Grattan admitted Exhibits A and B into the record (see attached). He found that pursuant to Colorado State Statutes 12-48-106, there are no grounds to deny the special events permit on the basis that it would be injurious to the public welfare, the nature of the special event (a local fundraiser), its location within the community (seems appropriate), or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found that the application for a special events permit submitted by Community Hospital Foundation, Inc. for the Tour the Valley Bike Ride was in order and approved it.

VI. <u>OTHER BUSINESS</u> – Review Hearing on Noise Issue

1. Breckenridge Ale House GJ, LLC dba Breckenridge Ale House, 2531 N. 12th Street, Grand Junction, CO 81501, Hotel and Restaurant

Robert Bradley, General Manager for Breckenridge Ale House, and Jonie Beckner, 1220 Bonito (within the neighborhood of Breckenridge Ale House) were present.

Ms. Kemp handed Hearing Officer Grattan a memo provided by Meghan Woodland from the Grand Junction Police Department which stated that since September 3, 2014, there was one noise complaint by Annette Collier on July 8, 2015 and the officers dismissed the call as unfounded.

Mr. Bradley advised that they have adjusted their music schedule and are trying to only have acoustic and less bass music after 8:00 p.m. He said they have received complaints about loud music when they have not even had live music

playing and he believes the music was coming from other venues. He advised that he not aware of any police warnings since the last review.

Ms. Beckner thanked the Authority for the review period. She said that there has been a great improvement as compared to the summer of 2014. There have been two occasions where her neighborhood had concerns. She said they emailed Ed Cerkovnik, President of Breckenridge Ale House GJ, LLC on June 4th advising him of loud music coming from Breckenridge Ale House on June 3rd. She did not receive any communication back from Mr. Cerkovnik or Mr. Bradley. The other date of a concern was July 8th, and they wrote to Mr. Cerkovnik again on July 9th. Ms. Beckner called Breckenridge Ale House on July 8th to request that the music be turned down. She was advised by the lady on the phone that loud music is allowed until 8:00 p.m. Ms. Beckner asked that a Manager on duty return her call but she did not receive one, therefore called for Police assistance to file an official complaint and to ask that the music be observed from her neighborhood. She did observe a patrol car go by but it did not stop and the band must have been on a break because the music was not playing at that time. She said that they are appreciative of the efforts that Breckenridge Ale House is making.

Hearing Officer Grattan asked Ms. Beckner if she believes anything further needs to be done. Ms. Beckner said it is evident that efforts have been made to address the issue and improvement has been noticeable and she requested that it continue to improve.

City Attorney Shaver asked Mr. Bradley to tell a little bit about the management structure at Breckenridge Ale House. Mr. Bradley said that he is at the establishment 50 hours a week but a lot of that time is during the day and not necessarily past 7:00 p.m. City Attorney Shaver asked if Mr. Bradley has communicated with his employees that are in the chain of command about the issue. Mr. Bradley said he has and he apologized to Ms. Beckner for the host that had been rude to her on July 8th and advised that the host lost her job because of that incident. All employees were advised of the importance of the situation and it is important that the managers know of every incident or complaint right away.

Hearing Officer Grattan suggested that Mr. Bradley give Ms. Beckner contact information for management on duty so that she has a viable point of contact to allow for easier communication. Mr. Bradley advised that he will be glad to give Ms. Beckner the names of the other two managers that would be on duty.






