ARCHITECTURAL DESCRIPTION: One story with hip roof and gabled front wing. Concrete block foundation. Concrete steps with uncoursed ashlar piers and flagstone coping, lead up to sunporch/entry with hip roof on east elevation of facade wing. Full height, squared column on porch outer corner. Wood shingles on half-wall. Porch glazed with ribbons of transom wood casements, three over two. Metal storm door. French front door. Windows around house are double hung wood sash, one-over-one. Storm windows with white vinyl frames. Gabled cutaway bay on east elevation. White simple drop wood siding with white trim. Foundation, steps and mortar of piers are burgundy. Small window in front pedimented gable has burgundy frame and sunbursts in the apex of the facade and east gables are multicolored. Gray composition shingle roof with boxed eaves and comices. Brick chimney on west slope.

Landscaped with lawn, roses along west edge of lawn and cottonwood trees on west elevation. Two sycamore trees in parking area. Rail fence along driveway on east elevation. Concrete block wall and wood fence around back yard.

One car garage with front gable, red roll composition roofing, white drop siding, and batten swinging doors with very large diagonal lights. Adjacent small storage building has same roof and siding. Alley access. Square concrete ashpit by alley.

HISTORICAL BACKGROUND (discuss important persons and events associated with this building): Built ca. 1904, 336 Chipeta was first lived in by George M. Heist, a railroad conductor, ca. 1904-1906. The next owner/occupant was Michael W. McConnell, a railroad engineer, ca. 1907-1910, followed ca. 1914-1921 by another railroad engineer, W. W. Barry, and his wife Lillian. Perhaps the most prominent owner has been (O.E.) Omri Daniels, one of the founders of Home Loan and Investment. He and his wife Josle were residents ca. 1922-1927. Lee Allison was the next owner, ca. 1930-1935, renting it to Ella and Phillip Burk, a driver, ca. 1930-1932. The next tenants were Angelina and Gus Diamanti, a wool grower, ca. 1935-1937. Edith and Roxie Ligrani were the owners ca. 1936 through at least 1951. The Ligranis rented the house to Helen and Roy Galligan, a railroader, ca. 1941, and were occupying the house ca. 1946.
