Wood step leads up to open porch with shed roof extending across facade. A cross gable on the west over the step. Three full height Tuscan columns across porch and two responds. Door is paneled and has a large light. Storm door. Windows are mainly double hung wood sash, one-over-one, and have metal frame storm windows. On the facade are four vertical lights over one. A bay on the west elevation has three small single light windows and a pentagonal hip roof. White simple drop siding. Gray door and window surrounds. Wood shingle roof. Boxed eaves and cornices. Porch gable is pedimented with two corbels. Other gables have return cornices. Brick chimney on ridge. Landscaped with lawn. Spirea and illacs across facade. Elm trees on west lawn. Locust tree in parking area. Chain link fence around front yard and wood fence around backyard. 
