 ARCHITECTURAL DESCRIPTION:
 One story with front hip on gables and battered foundation. Concrete front steps with wrought iron railings lead to projecting screened front porch with dropped hip on gable on west half of facade. Siding on half-wall and squared half column on front corners of porch. Front door is paneled with three vertical lights. Windows are double hung wood sash, with five or six vertical lights over one. Narrow lapped siding is white; foundation and gable faces have wood shingles painted gray. Door and window surrounds, bargeboards, corner boards and water table are gray. Brick chimney on west slope. Composition shingle roof with knee braces and exposed rafter ends. Bargeboards have notched tails. Landscaped with lawn and beds of annuals along foundation.

 Original garage at rear, ca. 1915, with drop siding, front gable with hip on roof, and original swing-out doors. A new addition has been added on to rear of garage.
