ARCHITECTURAL DESCRIPTION: One and a half story with concrete block foundation. Broad concrete front steps with large piers lead to full width, screened front porch under principal roof. Four concrete piers support large tapered wood piers. Siding on half-wall. East third of porch is glazed with ribbons of twenty light, wood casement windows. Flush front door with single large beveled light flanked by tall, beveled, single pane sidelights. Additional windows are double hung wood sash, three vertical lights over one, some having three light transoms. Projecting bay supported by wall beams on west elevation, with flared shed roof. Large front dormer is stucco with half-timbered gable. Dormer opens to a second story porch. Four piers with lapped siding, and balustrade with vertical stats. Gray narrow lapped siding. Wood piers, windows, door frames and bargeboards are white. Light gray composition shingle roof with flared saves and knee braces. Rafter ends and bargeboards are deeply notched. Gray painted brick end wall fireplace chimney on east elevation. Another gray fireplace chimney towards rear of east elevation.

Landscaped with lawn, trellis with climbing roses south of sunporch, builb plantings to the west of porch. Two sycamores in parking area. Original two car garage at rear with front gable, clapboard siding, and new panel garage door.

Married: Pearl Bannister, 30 July 1908. Children: Laura, Louise and James, Jr. Career while in house (1910-1922?): Grand Junction Fruit Growers Association for 13 years, beginning in 1908. He became manager in 1915. His obituary notes that he had much to do with "making the local association one of the most successful and influential in the West." It also states that he was "interested in numerous other well-known local financial and business enterprises." Organizations: He was one of the charter members of the local Elks Lodge, serving as one of its first exalted rulers. (His wife, Pearl, was engaged in the family business, Bannisters, for a number of years.)

Blodgett, Elbert D: Born: 1874, New York. Died: 5 Nov 1953, LaJolla, CA. Married: Jane L. Children: Mrs. Nancy Denslow. Career while in house (1922-1951): Vice president of US Bank of Grand Junction. After the merger of US Bank with US Bank and Trust Company, he was elected president of United States Bank of Grand Junction. He retired from the position of president after the bank was sold in 1948. He also engaged in extensive farming and sheep raising operations for a number of years. Organizations: Masonic organizations including York and Scottish Rite bodies, and the Shriners; Elks Lodge; and the Lions Club.

This house should be examined closer at a later date for association with Allen Jones, manager of the Atomic Energy Commission Compound.


