

ARCHITECTURAL DESCRIPTION: One story with front gable roof. Foundation skirted with lapped board siding. Concrete stoop with wrought iron railings in center of facade covered by a bracketed, pedimented gable canopy. Paneled front door. Windows around house are black metal frame sliding and double hung metal sash windows. Beige, lapped board siding. Windows surrounds, canopy brackets, stoop and railings, raking cornices are red. Tan, metal ridge roof. Brick chimney in ridge. Small, arched, louvered opening in gable.
 Very small grass lot.

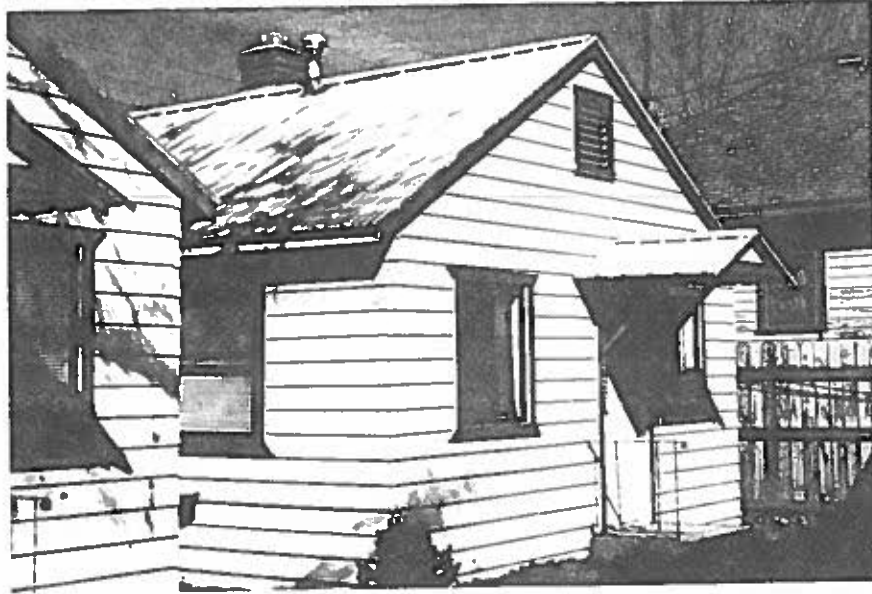
