ARCHITECTURAL DESCRIPTION: One and a half story with cross gables and comice returns. Exposed concrete block foundation. Concrete steps lead to a wrap-around porch in the northeast corner. Half-wall is shingled down to ground level. Four full height, squared porch posts and two fluted Doric wall pliasters. Two porch entrances, each with a wooden screen door, paneled front doors with single light. Narrow wood steps lead to canopied, single bracketed entrance in southwest corner with narrow paneled door. Majority of windows are double hung sash, one-over-one. Large fixed pane picture window with diamond pane transom in south side of facade. Two French windows in upper facade. A Chicago window and a shed roof bay window in the north elevation. Louvered openings in peaks of gables. Gabled dormer has double fixed pane windows. Wide lapped wood siding is salmon. Shingles in gables and porch half-wall are a darker salmon color. Window surrounds, corner boards, bracketed canopy, fluted Doric pilasters and porch posts are

white. Foundation, window frames and surrounds lintels are turquoise. Raking cornice, cornice returns, fascia and string course are white and turquoise. Green composition shingle roof with boxed eaves.

Landscaped with lawn with several moderately sized trees and group of pines. Wood fence enclosed the north side of lot and all of small backyard.
