ARCHITECTURAL DESCRIPTION: Two story, with parapet shed roof. One section of long, two story building. Covered concrete loading dock. Loading dock roof supported by steel girder piers. Exposed metal rafters. Corrugated metal roof continuous over this long loading dock. Loading dock leads to a single, segmental brick arch entrance. Entrance has rolling metal door. Segmental brick arch window openings on first and second story now filled in with bricks. Three row brick cornice of roof parapet continuous with rest of building. Brick building is painted gray.

In 1944, J.W. Milne was the owner through 1946 when it was purchased by present owners, Thomas and Aileen Litton. In 1916, J.S. Brown Mercantile was at 437-439 South Avenue. By 1924, J.W. Milne was operating his transfer and storage business from 433 and 437. In 1926, Milne Fuel Company was added and by 1941, the Safeway office and warehouse had moved to 437. They were there until 1954. Tenants since that date use the 433 address.


