ARCHITECTURAL DESCRIPTION: One story with hip roof. Concrete steps with concrete piers and coping lead to sunporch/entry with continuous shed roof that extends across entire facade. Porch half-wall is concrete and extends down to ground level. Porch is glazed with ribbons of metal casement windows with six and nine large lights. Upper porch wall between windows is covered with false bevel siding. Front door is paneled with fan light window. Windows are double hung wood sash with wood framed screens. Wood Shake shingle siding is light gray. False bevel siding and concrete half-wall of porch are light gray. Front door, window frames and surrounds, and corner boards are dark gray. Red composition shingle roof. Corrugated shed roof carport, supported by iron posts, on west elevation.

Lawn on elevated front yard which has concrete retaining wall and concrete steps. Decorative wrought iron fence on top of retaining wall. Tall wood fence along west side of lot. Many moderately sized trees around yard. Large shrub along northwest corner of facade. Three small, raised flower beds next to street.

Single car garage at rear with front gable, green roll asphalt roof, and olive green simple drop siding. Corner boards and raking cornices are dark green.

HISTORICAL BACKGROUND (discuss important persons and events associated with this building): The house at 1025 Hill Avenue, although listed as being built in 1898, does not show up at this location on the assessor's records until 1918. It is, however, listed as being the home of Aaron A. Robinson, a niner, plasterer and, later pastor of the Church of God from 1905 until 1915. It was the home of Grand and Anna B. Carothers from 1920 through 1935. Ar. Carothers owned Grand Rug Works which was located next door at 1021 Hill. The house was home to Clarence and Gladys Hurd, a clerk at East 3/de Grocery from 1939-1941. Renters Gordon and Virginia Adams, a brakeman with Denver and Rio Grande Railway, were living in the house by 1946.


