## 2015 Police Pension Rates

The 2015 Pension Rates were distributed to those present. Human Resources Director Claudia Hazelhurst explained that the sheets distributed included implementation of a partial market adjustment of the pension rates up to 2.5%. There was no adjustment for Phyllis Stafford. Those with limited rank were adjusted another .6%. There were two pensioner deaths in 2014 – Verna Baxter and Georgia Brown, both spousal beneficiaries.

Financial Operations Director Romero moved to approve the 2015 Pension Rates as presented. City Clerk Tuin seconded. City Attorney Shaver asked the motion to be amended to note that line 13 Georgia Brown should be removed. The motion was amended by Financial Operations Director Romero and the amended motion was seconded by City Clerk Tuin. Motion carried.

# Actuarial Study

Benefits Coordinator Shelly Williams reported that due to the change in the Governmental Accounting Standards (GASB), the actuarial study will not be available until February.

Pensioner Nita Gorby asked if the State is no longer responsible for any liability with the fund. Human Resources Director Hazelhurst advised that the State did fulfill their obligation with the pension funds. They expedited making the plans whole and satisfying their obligation due to the accounting rules being changed.

#### Question and Answer

City Clerk Tuin inquired if the pensioner rates will be revisited if the general employee pay rates are adjusted midyear. Human Resources Director Hazelhurst replied that will be reassessed if that does occur.
