NOTICE IS HEREBY GIVEN that the City of Grand Junction, Applicant, will appeal to the Colorado Supreme Court from the Order entered April 29, 1975, denying Applicant the right to store the 7.81 c.f.s. paramount direct flow. This appeal is taken pursuant to the Order entered October 3, 1975, and mailed October 7, 1975, denying Applicant's Motion For Amended Order or New Trial.

The water right sought to be reviewed is the right of the City of Grand Junction, under application made January 23, 1973, to store and impound its Paramount water right of 7.81 c.f.s. when it is not required immediately for municipal purposes.

The City of Grand Junction, Colorado, is the Appellant. Appellees are the Kannah Creek Water Users Association, Lloyd V. Wright, Jennie M. Wright, the Kannah Creek Extension Ditch Association, and Ralph Kelling, Jr., Division Engineer.
