#### 1. SCOPE

- 1.1 The City of Grand Junction is soliciting competitive quotes from qualified and interested companies to provide bicycles for Grand Junction Police Department (GJPD). Bicycles will be used by the Bicycle Patrol Division of GJPD to patrol the general public, special events and other social gatherings.
- 1.2 **The Owner:** The Owner is the City of Grand Junction Police Department. The term Owner means the Owner or his authorized representative.

#### 2. REQUIREMENTS/SPECIFICATIONS

#### 2.1 General Requirements & Specifications

2.1.1 Delivery of Quotes: Offerors shall submit their quote to the City of Grand Junction stated date, and time as stated on cover page of this RFQ. Late quotes will not be considered. Please email quotes to <a href="mailto:susanh@gicity.org">susanh@gicity.org</a>.

#### 2.1.2 Specifications:

- A. Bicycles shall be Surly Wednesday or Diamondback El Oso De Acero *or exact equivalent*.
- B. Bicycles shall have steel frame. Aluminum is not acceptable.
- C. Bicycles shall have fat tires.
- D. Supplier shall provide detailed specification sheets for all bicycles offered.
- E. Supplier shall provide any necessary training to GJDP staff on special features, operation, maintenance and general care of bicycles.
- F. Warranty and delivery information shall be provided on Response Form
- G. The number of bicycles to be purchased shall depend on quotes received; it is expected the purchase quantity shall be between five and seven.
- 2.1.3 It is the Owner's intention to make an all or none award. However, the Owner reserves the right to split the award, should the Owner find it necessary to do so.
- 2.1.4 Award(s) shall be based upon the lowest responsive and responsible Quote that meets the required specifications and demonstrated capabilities.
- 2.1.5 Should it be determined that a demonstration is required, Supplier shall make available a demonstration of their proposed model.

- 2.1.6 All prices submitted by Offeror on the attached response form shall include: shipping (FOB Destination), assembly, and training charges.
