Offerors responding to the above referenced solicitation are hereby instructed that the requirements have been clarified, modified, superseded and supplemented as to this date as hereinafter described.

Please make note of the following clarifications:

**NOTE:** Typographical errors were made in Addendum 2. Please see the corrections to those errors, to include corrections to the Revised – Price Bid Schedule. Also, the terms "Add" and "Deductive" shall be removed from the Revised – Price Bid Schedule, and the Owner shall make the determination as to which Alternate Pricing options they chose to select, if any.

- Contractor shall utilize the attached Revised Price Bid Schedule when submitting their bid responses. The Revised – Price Bid Schedule has been changed to include deductive alternates for Item 6, A of Addendum 2 Addendum 1.
- Further clarification for Item 12, A of Addendum 2 Addendum 1, the term "balusters" also is referring to "posts". These are the same items, and refer to the main supports for the deck and guardrail/handrail systems. The "pickets" are the intermediate members for the guardrail/handrail system.

The original solicitation for the project noted above is amended as noted.

All other conditions of subject remain the same.
