#### ALTERNATE HEARING OFFICER SAM D. STARRITT

#### I. CALL TO ORDER

The meeting was called to order at 2:00 p.m. Those present were Alternate Hearing Officer Sam D. Starritt, City Attorney John Shaver, and Deputy City Clerk Juanita Peterson.

### II. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

- 1. DLK Enterprises Inc., dba The Brass Rail, 476 28 Road, Grand Junction, CO, 81501-7936, Tavern
  - No one was present representing the applicant. The renewal for DLK Enterprises Inc., dba the Brass Rail was found to be in order and approved.
- 2. Nepal Restaurant GJ, LLC dba Nepal Restaurant, 356 Main Street, Grand Junction, CO, 81501-2413, Hotel and Restaurant with Outdoor Dining Lease
  - No one was present representing the applicant. The renewal for Nepal Restaurant GJ, LLC dba Nepal Restaurant was found to be in order and approved.
- 3. SINH, LLC dba Redlands Liquor, 2500 Broadway, Space A8, Grand Junction, CO 81507, Retail Liquor Store
  - No one was present representing the applicant. The renewal for SINH, LLC dba Redlands Liquor, 2500 Broadway, Space A8 was found to be in order and approved.

It was noted that dates on their lease would need to be adjusted since they have changed the time frame for their relocation.

### III. <u>APPLICATION TO RENEW LIQUOR AND BEER LICENSES WITH MODIFICATION OF PREMISES</u>

  - Modification of Premises Remove partition wall and extend store area 23 feet east, totaling an additional 1,265 sq. feet.

Meng Truong, owner, was present. The paperwork for the renewal was in order and approved. The request for the modification of premises was approved. The needs and desires was conducted recently on a prior modification and Hearing Officer Grattan previously approved the exception to not conducting another one for just removing this wall and adding square footage. The application for the renewal and modification was approved.

#### IV. APPLICATION FOR A SPECIAL EVENTS PERMIT

 "Grand Junction Renaissance Faire - 2016", April 29, 2016, 3:00 p.m. to 8:00 p.m., April 30, 2016 from 10:00 a.m. to 8:00 p.m., May 1, 2016 from 10:00 a.m. to 4:00 p.m. located at 715 Struthers Avenue, Grand Junction, CO 81501, Malt and Vinous

Representative of Juniper Ridge Community School: Tammy Meyers, 3215 Rood Avenue, Clifton, CO 81520

Events Manager: Grace Rupp, 515 N. 5<sup>th</sup> Street, Grand Junction, CO 81501

Grace Rupp, event manager, was present.

City Attorney Shaver provided Ms. Rupp with three documents, the first two marked with an "A" and the third one marked with a "B" and asked Ms. Rupp if she has personal knowledge of those documents. Ms. Rupp said she did as she is the one who created them. City Attorney Shaver asked why they were created. Ms. Rupp said as part of the paperwork for the Grand Junction Renaissance Faire they are having on April 29 thru May 1, 2016. City Attorney Shaver asked about the history of the event, how many years has it been held. and have there ever been any problems with the service of alcohol. Ms. Rupp said there have been other Renaissance Festivals but this is the first time for the school to host one. City Attorney Shaver said that the questionnaire indicated that there would be 10 security personnel and asked Ms. Rupp to explain how they arrived at that number. Ms. Rupp said this was the recommendation from Citadel Security. Citadel Security will check ID's and man the entrance to the beer garden. The Board of Directors for the school will serve the alcohol and they will have overnight security by Citadel at the event location. City Attorney Shaver asked Ms. Rupp what the nature of the event is. Ms. Rupp said this is community based charter school and this will be a fundraiser for the school. The alcohol is a sub-piece of the event. They will have a variety of City approved food vendors. City Attorney Shaver asked Ms. Rupp to describe what is depicted on Exhibit B. Ms. Rupp said the beer garden area is 100' by 50' and the entire area will be fenced in with temporary fencing. They will use a natural tree line in the area to base the fencing on. There will be only one entrance and one exit. Citadel will make sure persons of the proper age will have a wristband after their ID is checked. City Attorney Shaver asked whose signature is on page 2 of Exhibit A. Ms. Rupp said it is hers. City Attorney Shaver asked if her signature represents that the information contained on that document is true and accurate. Ms. Rupp said yes.

Alternate Hearing Officer Starritt asked Ms. Rupp if all the other paperwork needed is complete. Ms. Peterson said the rental agreement with Grand Junction Parks and Recreation Department along with the Certificate of Insurance was in order. Alternate Hearing Officer Starritt asked if the staff and volunteers are trained in alcohol service. Ms. Rupp said they would be TIPS trained. Alternate Hearing Office Starritt asked to make sure at least one person per shift was TIPS trained.

There was no one present in opposition of the application

Alternate Hearing Officer Starritt admitted Exhibits A and B into the record (attached) and found that pursuant to Colorado State Statutes 12-48-106, there are no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event (it is a community activity), its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found that the application for a special events permit submitted by Juniper Ridge Community School for the Grand Junction Renaissance Faire 2016 was in order and approved it.

Lodge Secretary: Terri Carter, 2510 Broadway, Grand Jct., CO 81507 Events Manager: Chris Vigil, 960 Santa Clara Avenue, Grand Junction, CO 81503

Ms. Terri Carter, Lodge Secretary, and representatives of Smooth Productions were present.

City Attorney Shaver provided Ms. Carter with three documents, the first two marked with an "A" and the third one marked with a "B" and asked Ms. Carter if she has personal knowledge of those documents. Ms. Carter said she did as she is the one who created them. City Attorney Shaver asked why they were created. Ms. Carter said they are part of the paperwork for the Cinco de Mayo After Party 2016 they are hosting along with Smooth Productions on May 7, 2016. City Attorney Shaver asked about the history of the event, how many years has it been held, and have there ever been any problems with the service of alcohol. Ms. Carter said this is the first year for the Elks Home Association to host this event. Smooth Productions did the event last year at a different location. Ms. Carter said the Elks Home Association has lots of experience with numerous Special Events in the past such as Oktoberfest. City Attorney Shaver asked what is the relation between Smooth Productions and the Elks Lodge. Ms. Carter said Smooth Productions will be responsible for the music side of the event, they are a co-host. City Attorney Shaver asked Ms. Carter to explained Exhibit B and the front vestibule and terrace that will be part of the licensed premise. Ms. Carter said they will have temporary fencing across the stairs into the building. The event will use the Elks Lodge bartenders and Elks members for part of the security. City Attorney Shaver asked if this is for profit

and who is the beneficiary of this event. Ms. Carter said it is for profit for Smooth Productions. City Attorney Shaver asked who's signature if on the second page of the questionnaire. Ms. Carter said it is hers. Alternate Hearing Officer Starritt said he is concerned about the two companies and if they have the right applicant. Ms. Carter said they are only providing the location for Smooth Productions. City Attorney Shaver said that is why he asked about the relationship. State Statutes 12-48-103 et. seq. is for the benefit of non-profit. After a brief discussion, City Attorney Shaver explained that special event permits are for non-profits and that the Grand Junction Elks Home Association is the applicant. City Attorney Shaver asked about the contract between the two.

Alternate Hearing Officer Starritt said he would like to take this under advisement, but would like to review the contact. Alternate Hearing Officer Starritt would like to continue until May 4<sup>th</sup>. The profit aspect is what the concern is. Alternate Hearing Officer Starritt said if there was an agreement in place that outlined that the Elks Home Association agrees to hire Smooth Productions, LLC to conduct the music for the Elks Special Event, and if the Elks Home Association is the true applicant, he would approve the event permit.

Ms. Carter said they were not trying to do anything illegal, but was not aware of this rule since Smooth Productions did the same thing last year at another event. She will bring a new agreement to the City Clerk's office. Ms. Peterson will forward this to Alternate Hearing Officer Starritt and City Attorney Shaver to see if they agree.

There was no one present in opposition of the application.

Alternate Hearing Officer Starritt admitted Exhibits A and B (see attached) into the record. If the agreement (see attached) is satisfactory, he will find the application for a special events permit submitted by Elks Home Association for the Cinco de Mayo after Party 2016 is in order and it will be approved.

Co-founder/Event Manager: Jesse Daniels, 191 Turner Ave., Whitewater, CO 81527

Mr. Jesse Daniels, co-founder and event manager, was present.

City Attorney Shaver provided Mr. Daniels with three documents, the first two marked with an "A" and the third one marked with a "B" and asked Mr. Daniels if he has personal knowledge of those documents. Mr. Daniels said he did as he is the one who created them and this is the third year for this event. City Attorney Shaver asked about the nature of the event. Mr. Daniels said it is the LGBT (Lesbians, Gay, Bisexual, and Transgender) Festival. City Attorney Shaver asked if it was a social event and fundraiser and if there have been any problems with the service of alcohol. Mr. Daniels said yes, it is a fundraiser and there have not been. City Attorney Shaver asked Mr. Daniels to describe how

the liquor sales will be conducted lawfully. Mr. Daniels described the liquor sales areas and how they will be contained and how ID's will be checked, only 21+ will be allowed in those areas. City Attorney Shaver said that the second page of the questionnaire, there is a signature and asked Mr. Daniels whose signature that is. Mr. Daniels said it is his. City Attorney Shaver asked if he is saying the information to be true and accurate in the questionnaire. Mr. Daniels said that is correct.

Alternate Hearing Officer Starritt said the application indicates the event has been held for three years. Mr. Daniels said that is correct. Alternate Hearing Officer Starritt asked if the security is approximately the same as in the past. Mr. Daniels said that is correct. Alternate Hearing Officer Starritt asked if the estimated number in attendance was from years past. Mr. Daniels said that is correct. Mr. Daniels said there are not as many competing events this year but they will be staffed accordingly. Alternate Hearing Officer said he was having a hard time figuring out where this location is at. Mr. Daniels explained the location, an old lumber store, and the space is indoors and outdoors.

Ms. Peterson asked Mr. Daniels if that the FTA (failure to appear) was taken care of. Mr. Daniels said it had been.

There was no one present in opposition of the application

Alternate Hearing Officer Starritt admitted Exhibits A and B into the record (attached) and found that pursuant to Colorado State Statutes 12-48-106, there are no grounds to deny the special events permit, it would not be injurious to the public welfare because of the nature of the special event (it is a community activity), its location within the community, or the failure of the applicant in a past special event to conduct the event in compliance with applicable law. He found that the application for a special events permit submitted by Colorado West Pride for the Colorado West Pride Festival 2016 was in order and approved it.

#### V. APPLICATIONS FOR NEW LICENSE – RESOLUTION, FINDINGS, AND DECISION

1. Mary's Homestyle Cooking Inc., dba Mary's Homestyle Cooking, 230 Lynwood Street, Suite G&H, Grand Junction CO 81503, Hotel and Restaurant

President/Sec.: Johnny Maestas, 146 29 Road, Grand Junction, CO 81501

Johnny Maestas, owner, was present. Ms. Peterson reported the paperwork was in order and the reports are waiting for final inspection. Ms. Peterson said on Mr. Maestas Individual History Records (IHR), he did not reveal two charges; he has since amended his IHR. He has provided a letter regarding the charges; Alternate Hearing Officer Starritt said he would just make this part of the record that there would be no need to read it into the record. Alternate Hearing Officer asked Mr. Maestas to approach to review the letter to make sure it is what he wrote and his signature and Mr. Maestas confirmed it was (see attached).

Ms. Peterson read the survey results into the record (see attached). City Attorney Shaver asked Mr. Maestas if he agreed with the results Ms. Peterson just read. He agreed. City Attorney Shaver asked who conducted the survey. Mr. Maestas said Mr. Jim Dunn. Mr. Dunn was present. City Attorney Shaver asked Mr. Dunn if he heard what Ms. Peterson read into the record. He said he did. City Attorney Shaver asked if he believed this to be true and accurate. Mr. Dunn said he did; Mr. Dunn said he had to go back out and get additional signatures of businesses. City Attorney Shaver asked Mr. Dunn how he presented the survey and he described how he conducted the survey. City Attorney Shaver asked Mr. Dunn what is his relationship is to this license. Mr. Dunn said he is the kitchen manager.

Alternate Hearing Officer Starritt had a couple of questions for Mr. Maestas if he was over the age of 18 when these incidents occurred. Mr. Maestas said one was before and one was when he was 18. Alternate Hearing Officer Starritt asked Mr. Maestas why he did not reveal these charges in the beginning. Mr. Maestas said his mother helped him complete this information and he didn't review it accurately and just signed it due to working at getting the restaurant going, and he apologized. Alternate Hearing Officer Starritt asked Mr. Maestas if he is no longer drinking and explained how that relates to this license he is applying for. Mr. Maestas said he was no longer drinking and understands the impact if could have on his business.

Alternate Hearing Officer Starritt asked if there was anyone present who objects to this license being issued. There was no one.

Alternate Hearing Officer Starritt approved the issuance of the new license. The City Clerk's office will prepare a resolution for the Alternate Hearing Officer's signature.

#### VI. REVIEW OF APPLICATION FOR PERMANENT DISTILLERY SALES ROOM

 Blu Cellar Door, LLC dba Highlands Distillery, 1888 Deer Park Circle North, Grand Junction, CO 81507

Tasting Location – 782 24 Road, Grand Junction CO 81505

Mr. Dylan Proietti, manager of the facility and distillery, was present.

Alternate Hearing Officer Starritt gave a background that these were previously approved on a State level. The statute has recently changed and needs local approval.

City Clerk Stephanie Tuin presented the information for the record. Due to it being a permanent location, it has been reviewed with the criteria on impact of traffic, noise, other neighborhood concerns and local zoning laws. Ms. Tuin reviewed what the applicant has done for this property and said that it has been rezoned. The Planning Department has no concerns and has approved this application. Ms. Tuin said it appears the criteria has been met.

Alternate Hearing Officer Starritt asked Mr. Proietti to explain the process the applicant has went through. Mr. Proietti said it began in 2014 and has been a long process. All agreements are in place with the Federal and State levels. Mr. Proietti said they are still in the construction phase and there is a lavender farm on the site.

Alternate Hearing Officer Starritt approved the request in relationship to regulation 47-428 which complies with applicable statutes and regulations and the proposed use will not have an adverse impact on traffic, noise, or other neighborhood concerns in a manner that is inconsistent with local regulations or ordinances.





Mary's Homestyle Cooking Inc., filed an application with the Local Licensing Authority on March 9, 2016 for a new hotel and restaurant liquor license permitting sales of malt, vinous, and spirituous liquors by the drink for consumption on the premises at 230 Lynwood Street under the trade name of Mary's Homestyle Cooking. The application and supplementary documents were reviewed, found to be in order and accepted. A copy was sent to the State Liquor Enforcement Division for a Concurrent Review. The hearing date was set for April 20, 2016. The Notice of Hearing will be given by posting a sign on the property on or before noon on April 6, 2016 and by publishing a display ad in the Daily Sentinel on April 1, 2016.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. The neighborhood was defined as the area bounded on the North by Lexington Court, Colorado River on the South, Beaver Street on the East and Clymer Drive on the West and included both sides of the streets as the outer boundaries.
