DESCRIPTION OF INTEREST

The Grand River Mosquito Control District (GRMCD) is a Colorado Special District that is charged with mitigating mosquito/human interactions in its Service Area in the Grand Valley. Mosquitoes are responsible for the spread of many arboviruses which are considered a major health risk to humans. Mosquito mitigation is the prescribed method for limiting the spread of these and like disease threats.

To accomplish the task of mosquito control in the Grand Valley, the GRMCD identifies stagnant water sources where juvenile mosquitoes develop into adults, monitors the stagnant water for mosquito activity. and applies larvicides to the water sources found to have mosquitoes present.

In addition, the GRMCD conducts area-wide surveillance of adult female mosquitoes to determine the scope of the issue, and to identify the presence of disease spreading vectors. The GRMCD prepares adult mosquito samples for local and state agencies to test for the presence of disease.

RIGHT OF ENTRY CONSENT

- and map attacked & From a. The GRMCD shall only access the property(s) identified in this document and work to mitigate mosquitoes if permission is granted, in writing, on this Right of Access Consent
- b. The Authorized Agent hereby grants permission to GRMCD employees, and assigns to access the Property for a period of one year from the date of this consent and which will automatically renew for additional one year periods unless terminated by either party.
- c. This Consent is for the purpose of mitigating mosquito/human interactions by conducting regular mosquito control activities which may include but are not limited to:
 - Identifying locations where juvenile mosquitoes develop into adults

- Monitoring stagnant water for mosquito activity
- Applying pesticides to the areas found to have mosquitoes present
- Monitoring adult mosquito populations.
- d. Any and all mosquito mitigations conducted by the GRMCD will be at the sole cost of the GRMCD and shall be conducted in a responsible, professional, and lawful manner.
- The Authorized Agent shall not be responsible for the actions of the employees or assigns of the GRMCD while they labor on the property.
- f. The GRMCD will access properties for the purpose of performing mosquito mitigation from the first of March through the end of October. Access to the Property will be conducted during daylight hours Monday through Friday. Access that occurs outside these parameters will be communicated and approved of by the Authorized Agent.

g. Upon request, the GRMCD will honor reasonable, special instructions for accessing the Property.
